1. PREAMBLE:

4. OPENING OF TENDER:

- (a) Tenders will be opened at the prescribed date and time in the presence of tenderers or their representatives who choose to be present. The representatives of tenderers who attend the tender opening must produce their identification proof and authorization letter from the companies.

5. **AGREEMENT:**

6. PRICES AND OTHER CONDITIONS:

- (a) The tender document should be signed by the tenderer at the bottom of each page with the office seal duly affixed.
- (b) Tender should be legible and correction if any should be attested by full signature by the authorized signatory of the tenderer with date before submission. Corrections done with correction fluid should be duly attested.
- (c) Premium rates should be quoted in the Price Offer. Taxes applicable must be mentioned separately, as noted in the column.

8. SPECIFIC TERMS AND CONDITIONS FOR INSURANCE POLICY:

- a) Payment of Rs.7,02,000/- (Rupees Seven Lakhs and two thousand only) should be paid to legal heirs of Employees / Workmen who are covered under EPF MP Act 1952 for the period from **31.07.2022 to 30.07.2023.**
- b) All the members of the Employees Provident Fund Scheme are covered as members of the Employees Deposit Linked Insurance Scheme.
- c) On the death of the member while in service, the nominee and other persons entitled to receive the assurance benefit.
- d) Whenever, the Government of India increase the quantum of benefit the insurance company also should pay the benefit to the legal heirs, for which employer will pay the differential premium amount as per the rules and regulations.
- e) Employees recruited on or after **31.07.2022** and enrolled under EPF Scheme should also be included in the EDLI Scheme, for which separate staff data will be given.
- f) EDLI Payment should be settled to the legal heir within 15 days from

9. **INSURANCE PREMIUM**:

12. AWARD OF TENDER:

- a) In case of rates offered by two firms being equal, the decision of the TNCSC will be final.
- b) The tenderer offering the least rates of premium and best of package will be selected as "L1" tenderer which cannot be questioned by other tenderers.

13. ARBITRATION:

a) In case of any dispute in the tender including the interpretation of any of the clauses of the tender or the agreement, the matter shall be preferred by the TNCSC / tenderer to any one of the arbitrators in the panel of the arbitrators appointed by TNCSC, approved by the Board of Directors of the TNCSC. The list of arbitrators will be sent to the tenderer on demand by the TNCSC and the tenderer on receipt of the communication from the TNCSC shall select an arbitrator. In case if there is no reply from the tenderer within 15 days, TNCSC reserves the right to choose any one of the arbitrators from the panel of arbitrators and refer the dispute by filing claim.
