The due date for submission of "COMMERCIAL BID" (Commercial Bid, EMD details along with DD) and "PRICE BID" is <u>08.07.2022 at 3.00 PM.</u>

- 8. SCOPE OF WORK: Sale is on "AS IS WHERE IS BASIS / AS SUCH CONDITION AND NO COMPLAINT BASIS". Waste Paper (Imported Old Newspaper, Imported Box Board Cuttings, Indigenous Old Newspaper & Imported Old corrugated containers) should be cleared without any accumulation. No complaint regarding quality, quantity or composition of the Waste Paper (Imported Old Newspaper, Imported Box Board Cuttings, Indigenous Old Newspaper & Imported Old corrugated containers) will be entertained. Loading of material will be on buyer's scope. However, on request of buyer, Forklift with the operator will be provided by TNPL on chargeable basis if available and manpower for assisting loading should be provided by buyer.
- 9. Rights of participation will be for people who after inspecting the material, pre qualify themselves by paying the EMD and who have not been previously blacklisted by TNPL. Final decision regarding participation will be with TNPL.
- 10. Sale confirmation, Sale Order, Invoices etc. will be released only in the name of the Buyer who has initially registered and participated in the Auction. There will not be any change between the registration and completion of transaction.
- 11. In the event of the failure of the Buyer by way of a default in payment for the material being disposed, partial lifting of Waste Paper (Imported Old Newspaper, Imported Box Board Cuttings, Indigenous Old News paper & Imported Old corrugated containers) or non-compliance of any of the terms mentioned herein, the contract will automatically stand terminated and the Security Deposit will stand forfeited for the breach of contract by the Buyer. In this case, the company reserves the right to dispose off the balance Waste Paper (Imported Old Newspaper, Imported Box Board Cuttings, Indigenous Old News paper & Imported Old corrugated containers) and the said Buyer will have no claim whatsoever.
- 12. While taking delivery of the waste material, if any damage is caused to the premises or other machinery lying nearby, the Company shall recover all such costs required to reinstate the damage into the original position and stop delivery of the material till all the costs are paid.
- 13. Material lifting shall be as per the guidelines of TNPL only. Buyer shall have no right to choose / pick the Waste Paper (Imported Old Newspaper, Imported Box Board Cuttings, Indigenous Old Newspaper & Imported Old corrugated containers).
- 14. INSURANCE FOR WORKMEN EMPLOYED BY THE BUYER: The buyer should submit Insurance Policy under workmen compensation Act / road safety for the staff / workmen engaged for coordination / material lifting by them before commencement of work. TNPL is not responsible for any accidents occurred to employees of buyer/ any other person engaged by the buyer.
- 15. **DRIVING LICENCE**: The drivers employed by the buyer shall posse's valid driving license and TNPL reserves the right to check these papers and certificate of Insurance as and when required. TNPL in no way be responsible for violation of transport regulations by the buyer and their crew.
- 16. The Buyer shall be responsible to ensure that their employees follow safety regulations and as per TNPL stipulations and other statutory regulations. Buyer shall ensure that all his workmen on site use safety belts, gloves, helmets, masks, Safety Shoes, Goggles etc., as necessary for their safety.
- 17. Once the Waste Paper (Imported Old Newspaper, Imported Box Board Cuttings, Indigenous Old News paper & Imported Old corrugated containers) are taken out of the factory gate, Buyer will be solely responsible for all sort of claims like shortage, missing parts, damage, incident, accident, loss of Waste Paper (Imported Old Newspaper, Imported Box Board Cuttings, Indigenous Old Newspaper & Imported Old corrugated containers) etc.

- 18. If the Buyer wish to take delivery of the Waste Paper (Imported Old Newspaper, Imported Box Board Cuttings, Indigenous Old News paper & Imported Old corrugated containers) through a representative, he must authorize the latter by a letter of authority, which shall be presented to the officer concerned. The officer concerned may in his entire discretion decline to act on any such authority and it shall be for the Buyer to satisfy the officer concerned that the authority is genuine. Delivery to such person shall be sole responsibility of the Buyer and no claim shall lie against the Company on any account whatsoever, if delivery is offered to a wrong person.
- 19. In case of any dispute regarding the contract, the decision of the Company shall be final and binding. If there is any dispute as to the last or highest bid, the dispute shall be determined by the company and their decision shall be final and binding to all.
- 20. Buyer and his men are subject to the security rule of TNPL in force while in the TNPL premises. Buyer's workmen, agents or representatives shall not commit any nuisance, theft or indulge in any anti-social activities in the premises and the Buyer shall be liable for the good conduct, safety and discipline of his workmen. In case of any such activity, delivery will be suspended and strict action as per law will be taken including forfeiture of EMD.
- 21. The quantity indicated against the lot is approximate and no guarantee can be given regarding actual quantity.
- 22. **Subletting of contract:** The buyer shall not assign or sublet the order or any part thereof or allow any person to become interested therein in any manner, whatsoever, without specific /written permission from TNPL.
- 23. Cancellation of order and penalty: In the event of not taking delivery of Waste Paper (Imported Old Newspaper, Imported Box Board Cuttings, Indigenous Old News paper & Imported Old corrugated containers) in time, TNPL reserves the right to dispose of the material as it deems fit at their own discretion to any other person and recover any loss due to this from the original buyer. Also in the event of unsatisfactory performance, TNPL reserves the right to cancel the order. In the event of such cancellation, the security deposit will be forfeited. In addition, TNPL also reserves the right to recover such amounts as it deems fit from the buyer towards the beach of contract and due to unsatisfactory performance. TNPL's decision will be final and binding.
- 24. Buyer must make their own arrangement for transporting the Waste Paper (Imported Old Newspaper, Imported Box Board Cuttings, Indigenous Old News paper & Imported Old corrugated containers) out of TNPL premises.
- 25. Any dispute arising out of the sale shall be subject to jurisdiction of Courts situated in Karur.
- 26. **Commencement & Completion of lifting of material**: The buyer shall commence lifting of material immediately within 3 days on receipt of intimation /award of sale order. The entire quantity of material should be lifted within 30 days from the date of receipt of intimation /award of sale order.
- **27. Inspection of material:** The buyer shall inspect the material available at TNPL site before quoting the tender. Imported Old Newspaper, Imported Box Board Cuttings & Indigenous Old Newspaper are available at TNPL unit II, Mondipatti, Manapparai district whereas Imported Old corrugated containers is available at TNPL unit I, Kagithapuram, Karur district.

## 28. Tenders liable for rejection:

- e. **Rejection of Tender:** TNPL will not assign any reason for rejection of any tender. TNPL shall have the right to reject any or all tenders/ to split order on two or more tenderers / to go for re-tender without assigning any reason / to release order on part quantity.
- f. TNPL WILL NOT RESPONSIBLE FOR TENDERER'S EMPLOYEES: The employees of the tenderer shall not be deemed to be in the employment of TNPL. If under any circumstances whatsoever and TNPL is held liable or responsible in any manner for the default or omission of the tenderer, TNPL shall reimburse from the tenderer for the same and also any other expenses or cost incurred by TNPL in any proceedings or litigation as a result of any such claim, demand or act on the part of the employees / representative of the tenderer.

- 1. New tenderers have to register their user ID in www.tnpltenders.com and shall inform to TNPL.

- 3. Tenderers must communicate their final bid amount by fax or E-mail to TNPL immediately after the bid event. This may be followed by a hard copy communication of price by post or courier.
- 4. TNPL's decision on sale order shall be final and binding.
