## **BID QUALIFICATION REQUIREMENTS**

## The Bidders shall become eligible to bid on satisfying the following Bid Qualification Requirements and uploading of the required documentary evidences. (Scanned copies)

- 1. The bidder should be either manufacturer or Authorized dealer of manufacturer of Governor Oil pump for pressurizing the hydraulic oil to the accumulator tank of Hydro Power Stations.
- 1.1 In case of manufacturer, copy of necessary documents such as copy of license, Permanent Registration certificate issued by the Department of Industries and Commerce/ UAM issued by the Department of Industries and Commerce and Udyam Registration Certificate as proof of manufacturer should be uploaded.
- 1.2 In case of authorized dealers, the dealers should produce a certificate from the principal manufacturer that they are the authorized dealers of that manufacturers. The authorized dealers also should upload the documentary evidence in respect of the principal manufacturer as in BQR 1.1 along with the offer.
- 1.3 The bidder should have supplied the tendered material manufactured by the same principal manufacturer to any State Electricity Boards or PSUs or Govt. of India or state government organization or Undertaking of Central Govt. or State Govt during the preceding Ten years as on the date of tender opening.
- 2) The tendered material supplied by bidder as covered by BQR1.3 should be in satisfactory operation for a minimum period of two years as on the date of tender opening during any time within the preceding ten years. The bidders should furnish the end user certificate for the above.
- 3) The annual turnover of the bidder shall be more than Rs.5,90,600/- (Five lakhs Ninety thousand six hundred only ) in any one of the last three financial years 2018-19, 2019-20 and 2020-21. In case of bidders who happen to be the companies registered under companies Act-1956, attested copy of Audited financial statements like, Profit and Loss A/c and Balance Sheet for all the preceding 3 years 2018-19, 2019-20 and 2020-21 should be furnished and in case of others, the Annual turnover certified by the practicing Charted Accountant or attested copy of income tax statements containing annual turnover for all the preceding 3 years 2018-19, 2018-19, 2019-20 and 2020-21 may be furnished as a proof of turnover.

## Note:

- 1. The bidders should upload the documentary evidences for the above along with the offer only. All the above documents shall be duly attested by a competent authority like Notary public, Gazetted officer etc.
- 2. The end user certificate should necessarily contain the date of completion of supply, date of commissioning and date of issue specifically to ascertain the period of satisfactory performance. If any clarification or need arises in the end user certificate it may be obtained separately by the tender inviting authority.
- 3. The offer of the bidders who have stated to be previous suppliers to TNEB/TANGEDCO/TANTRANSCO will be considered for further evaluation, even though they have not enclosed copies of end user certificate /Purchase Order after ensuring with concerned purchase order placing authorities.

## THE OFFERS OF BIDDERS NOT SATISFYING THE ABOVE BID QUALIFICATION REQUIREMENTS WILL BE SUMMARILY REJECTED.
