TENDER SCHEDULE

Sealed Tenders are invited in Two Cover System for Sizing/ un sized warping and beaming of Cotton and Polyester blended yarn from Sizing Mills those who are having experience in sizing/un sized warping and beaming of yarn suitable for Air jet Looms upto 9000 ends and upto 250 cms., width for our Air jet Weaving Unit at SIDCO, Kurichi, Coimbatore and Power loom Complexes at Aruppukottai, Sivagiri and Kurichi in accordance with the terms and conditions given below:

Terms and Conditions:

1. The rate shall be quoted for the sizing /un sized warping and beaming charges per kilogram weight / per metre of yarn including packing charges.
2. The Tenderer shall be capable of sizing/ un sized warping and beaming the required quantity of yarn in the required specifications in their **own unit** and deliver the sized/ un sized warping and beaming beams at the specified destinations.
3. The sized / un sized warping and beaming beams shall be in the required specification and shall be without any defect and to ease out the weaving process in Air jet Looms/Power looms.
4. The actual length for the yarn supplied shall be given with weight (Nett/Gross).
5. If the sized / un sized warping and beaming beams are defective and not suitable for weaving, such defective beams shall be taken back on your own expenses and the cost of the returned yarn and sizing / un sized warping and beaming charges paid shall be refunded to the corporation.
6. The required yarn for sizing/ un sized warping and beaming will be sent to the sizing unit at the cost of the Corporation.
7. Sizing/ un sized warping and beaming shall be carried out on priority basis as required by the corporation and shall be packed with cardboard on both sides of the beams and packed with hessian cloth in order to avoid damages on transportation.

8. The Corporation will bear the freight charges for the Sized/ un sized warping and beaming beams/despatch of Empty beams.
9. The baby cones shall be used after rewinding and the baby cones which are unable to rewind alone shall be returned to the Corporation.
10. The sized / un sized warping and beaming beams shall be delivered to the Complexes as per our delivery schedule after the receipt of the yarn bags.
11. The Sizing unit shall maintain the stock of the yarn, sized beams and empty beams in count-wise and unit-wise of the Corporation. The details should be sent to Tamilnadu Textile Corporation, Coimbatore every month on or before 7th. The Officials of the corporation and the unit shall be allowed to verify the stock at any moment.
12. The sizing/ un sized warping and beaming charges will be paid monthly after receipt of acknowledgements from the concerned Power loom Complexes/Airjet Weaving Unit. TDS in force and statutory deductions will be made from the sizing charges.
13. The required empty beams shall be arranged by the sizing unit. The Corporation will arrange to return the empty beams then and there.
14. The tenderers shall remit Rs. 90,000/- as E.M.D. by Demand Draft drawn in favour of "TAMILNADU TEXTILE CORPORATION LIMITED" payable at COIMBATORE. The EMD amount will not carry any interest.
15. The decision of the Corporation will be final for delay in supply of sized/ un sized warping and beaming beams and damages, the Sizing Unit shall accept the same.
16. The actual Elongation and Waste percentage shall be given to the Corporation which should be as per the norms given by Textile Research Association.
17. Insurance shall be covered by the Sizing Unit to the extent of the value of yarn supplied for sizing along with Agreement.
18. The count of the yarn supplied for sizing shall be tested and if there is any variation it shall be intimated to the Corporation and after obtaining clearance from the Corporation only the yarn shall be taken for Warping and Sizing. Any count variation will not be accepted after sizing / un sized warping and beaming.

19. The work order will be issued only to the owned sizing units. After getting work order no sub-contract will be allowed. In such cases the EMD amount will be forfeited and severe action will be taken against them.
20. The validity period of this contract will be for one year from the date of execution of the agreement. No rate increase will be given on any account within that period.
21. The tenderer shall submit the copy of the PAN & GST registration No. and Licence issued by local bodies to run the sizing unit.
22. The successful tenderer shall execute an agreement in 50 rupees stamp paper with the above terms and conditions and submit Insurance Coverage, PAN No, GST No and Licence issued by Local Bodies to run the Sizing Unit.
23. The Tenderers are required to simultaneously submit two separate sealed covers one containing TENDER PART-I along with E.M.D and cover second containing TENDER PART-II - Sizing rate quotation which will be opened only if the tenderer is found technically qualified to execute the tender.
24. The Tenderer has to submit the tender in Sealed Covers not later than **1.00 p.m.on 11.07.2022** superscribing as **"TENDER FOR YARN SIZING/ UN SIZED WARPING AND BEAMING"**.
25. Late receipt of tenders will be rejected.
26. The Cover-I of the tenders received will be opened on **11.07.2022 at 2.00 p.m.** by the Tender Committee at the above address in the presence of the tenderers present.
27. The Managing Director reserves the right to reject any or all the tenders without assigning any reason there for.
28. The tenders will be finalized as per the Tamilnadu Transparency in Tender Act 1998 and Rules 2000.
29. All disputes related to this tender will be within the jurisdiction of Coimbatore city only.

30. Any tenderer aggrieved by the order passed by the Tender Accepting Authority under Section 10 may appeal to the Government within 10 days from the date of receipt of order under Section 11 (1) of Transparency in Tenders Act, 1998.
31. The Tenderer should furnish the particulars as per the format enclosed in Annexure-I for each and every supply of Sized / un sized warping and beaming Beams.
