PART - I / TECHNICAL BID**

GENERAL TERMS AND CONDITIONS

1. Trichy District Co-operative Milk Producers' Union Ltd will not accept any variations in conditions stipulated in the tender.
2. Any suggestion in the tender, for any modification of the tender conditions will not be entertained and the conditional offer will render the tender invalid.
3. The tenderer can attend the pre bid meeting where the clarifications sought for by the tenderer will be given and the minutes of the pre bid meeting will be uploaded in the website.
4. The contract period for Butter / SMP vehicle is two year from the date of awarding of contract.
5. Any failure on the part of the tenderer in performing the contract for the full contract period will render the tenderer liable for penal consequences and liquidated damages as specified in the tender agreement which also forms part of tender document.
6. As this is a two part tender, the technical bid i.e. part – I consisting of pages 1 to 29 duly signed in each page, should be put in a separate sealed cover, super scribing on the envelope, “Part - I Technical Bid”, the Commercial Bid in Part – II in pages 30 to 350 should be put in other sealed cover, super scribing on the envelope “Part – II Commercial Bid”. Both the covers should be put in another sealed cover super scribing on the envelop “ The tender for **Hiring of refrigerated insulated Vehicle for transportation of Butter / Hiring of Closed Container vehicle for transportation of SMP** ”

7. The outer sealed cover should be addressed to General Manager, Trichy District Co-operative Milk Producers' Union Ltd, Pudukkottai road, Kottapattu, Trichy-23 and same should be dropped in the tender box kept in Main office on or before 19.07.2022 at 2:00 P.M.
8. The Union shall not be responsible for postal delay.

Precautions:

9. Tender form containing over writing, erased and rates not shown in words will be rejected.
10. In case of discrepancy in rates as shown in figures, and in words, the tender accepting authority will take the lower of the two.
11. The tenderer shall sign in every page of the tender document and shall ensure the document is complete in all respects.
12. The tenderer must satisfy himself thoroughly about the geographical area to be covered, nature of work, local conditions and the requirement of the Union before submitting his tender.
13. The person signing the tender should be the Proprietor / Partner / Managing Director or any other person duly authorized to sign the tender document. In the latter case, authorization letter should be attached.
14. The tenderer should read every page and understand the implications fully and offer the tender only if he could discharge the obligations set out in the tender documents.
15. The offer of the tender in the commercial bid should be valid for a minimum period of 120 days, from the date of opening of the Technical Bid.
16. If the tenderer has already been blacklisted by any Government/ Government Under takings/ Co – Operative societies, his tender will be rejected. In case information about such black listing comes to the knowledge of the Union after awarding of the tender, the contract will be terminated, liquidated damages levied, apart from taking penal action.

- (a) i. The tender shall be accompanied by an EMD @ Rs.70000.00 (Rs. Seventy Thousand only) for Hiring of refrigerated insulated Vehicle for transportation of Butter as Demand Draft drawn on a Nationalized Bank / Scheduled Bank in favour of **General Manager, Trichy District Cooperative Milk Producers' Union Ltd; payable at Trichy.**
- (b) ii. The tender shall be accompanied by an EMD @ Rs.90000.00 (Rs Ninety thousand only) for Hiring of Closed Container vehicle for transportation of SMP, as Demand Draft drawn on a Nationalized Bank / Scheduled Bank in favour of **General Manager, Trichy District Cooperative Milk Producers' Union Ltd; payable at Trichy.**
- (b) Tender without EMD will be summarily rejected.
- (c) EMD will not carry any interest.
- (d) EMD will be refundable to unsuccessful Tenderers by crossed account payee cheque after the tender is finalized.
- (e) If the Tenderer, for any reason, withdraws his offer (or) stipulates any conditions in his offer, the EMD will be forfeited.
- (f) The tenderer who claim exception from payment of EMD under the G.Os, should submit the copy of the G.O. In the absence of G.O. the tender will be summarily rejected.

18. In the case of successful tenderer, the EMD paid shall be adjusted against the Security Deposit payable to the Union.

Pre-Bid Documents

19. The Tenderer shall submit the following along with his tender document.

- (i) Photostat copy of PAN card
- (ii) Name and full address of his Bankers
- (iii) Photostat copies of (a) RC book, (b) Fitness Certificate, (c) Insurance Certificate, (d) Permit suitable for milk products transportation (e) Road Tax (f) Identity proof which can be a ration card, Aadhar card, Election Commission's ID card, Driving License (or) Passport.

Eligibility Criteria:

- 1) The turnover of the tenderer should be Double the value of the tender amount for each financial years for the last two years(2019-20, 2020-21)
 - 2) Should have minimum 2 years experience
 - 3) Should have transported Butter in refrigerated insulated vehicle or reefer vehicle to any cooperative institutions.
 - 4) Should have transported SMP in Closed Container vehicle to any cooperative institutions.
20. To prove his past experience, Photostat copy of the work order and the related performance report should be submitted along with the tender.
21. The R.C.Books of the Reefer vehicle/Closed Container vehicle shall be in the name of the Tenderer in the case of sole owner. If the Tenderer is in any partnership in force, R.C. Book shall be in the name of either the firm or one of the partners and in the case of companies the R.C. Book shall be in the name of the company (or) in the name of Director (or) duly authorized person on behalf of the company. In the case of Co-operative societies, the RC book shall be in the name of society or in the name of member of the society.

Provided an individual who is a sole owner and or partner in more than one firm and or a director of a company or companies and or a member of Co-Operative society or societies, having RC Books in his name shall offer his tender only in respect of any one of the above institutions viz. proprietary or firm or company or co-operative society. The tenderer should enclose the copy of the deed / agreement or other documentary evidence under statute to show that he is the sole owner/ Partner of a firm / Director of the company / member of co-operative society.

22. The documents submitted should be genuine and reflect the correct position as the tender accepting authority is guided by the documents filed by the tenderer. If a document of the successful tenderer is found to be bogus or false, apart from terminating the contract penal action will be taken for collecting liquidated damages from the tenderer.
23. The Butter / SMP Vehicle registered in the state of Tamil Nadu/All India permit are eligible to participate in the Tender.
24. The Tenderer should not offer vehicles which are already under operation in other DCMPUs / any other organization. Any violation of this condition should render the tender invalid. In case such violation is noticed after awarding of tender, the contract will be terminated and liquidated damages will be levied apart from blacklisting the tenderer.
25. (A) Butter is a perishable commodity and handling it requires experience. Hence the Tenderers shall have minimum 2 years experience with in the last 5 year period in Butter Vehicle with refrigeration and insulated operation in a Government / Government Under takings / Co-operative dairies. The 2 years experience of the Tenderer should be in the same name and style as the bidding entity. The five year period will be calculated proceeding from the date of publication of notice inviting tender. The tenderer should submit valid documents to prove his experience in transporting Butter.

(B) SMP is a perishable commodity and handling it requires experience. Hence the Tenderers shall have minimum 2 years experience with in the last 5 year period in SMP Closed Container vehicle in a Government / Government Under takings / Co-operative dairies. The 2 years experience of the Tenderer should be in the same name and style as the bidding entity. The five year period will be calculated proceeding from the date of publication of notice inviting tender. The tenderer should submit valid documents to prove his experience in transporting of SMP.

26. The Butter Vehicle / SMP Vehicle shall be in road worthy condition and its age must be lesser than 7 years on the date of publication of notice inviting tender. The age of the vehicle will be calculated from the date of first registration. The butter loaded should be delivered at the temperature not less than -5° Centigrade

Technical specification

27. It should keep the Butter / SMP without spoilage. The Butter / SMP vehicle shall have proper Insulated body and doors with sealing mechanism for safe transportation of Butter / SMP in good condition.
28. Any deviation from the specification to the disadvantage of the quality of Butter / SMP Vehicle would entitle the Union in taking penal action on the tenderer, including termination of contract.
29. In case Butter / SMP transported by the successful tenderer is spoiled due to any failure or lapses or deficiency in providing the above stated requirement, the tenderer should make good the loss as ascertained by the Union, apart from facing the penal action that may be taken against him under the contract.
30. Quality of service and time are the essence of the tender. The time schedule for the operation of Butter / SMP Vehicle will be given by the Union and the Butter / SMP Vehicle should be operated scrupulously following the time schedule, as any delay in same would cause loss, damage, impairment of quality of Butter / SMP.

31. The Butter / SMP Vehicle should have all the technical specifications enumerated in the tender document. The tenderer should enclose technical specifications for Butter / SMP Vehicle offered.
32. The authorities of the Union may inspect the Butter / SMP vehicle of the successful tenderer. After inspection if any suggestion is given for improved upkeep or maintenance or replacement of parts, the same should be carried out by the successful tenderer without delay.
33. If the authorities of the Union demand any record like Log Book, Trip sheet, R.C. Book, Insurance certificate, etc., the same should be produced.

Finalization of Tender

34. After opening the Technical Bid, the eligible tenderers will be called for the commercial Bid opening.
35. The Tenderer shall quote his rate which shall include all operating expenses (direct and indirect) toll fees, permit charges, wages, vehicle insurance, Cargo insurance etc. for transporting of Butter and transporting of SMP, Including loading and unloading.
36. The price of diesel prevailing on the date of publication of notice inviting tender will be taken for evaluation of the rates offered by the tenderers.
37. The rates quoted will remain firm throughout the period of contract. Once the contract is awarded to the tenderer, the charges payable to the tenderer for the work extended will be only at the rate accepted and finalized by the Union. Even during extension of contract period, the tenderer will be paid the same tender approved rate. The tenderer cannot claim any extra amount on this account.
38. The contract rate will not be adjusted for any variations in the price of diesel occurring subsequent to the date of publication of notice inviting tender.

39. The tenderer will be compensated for any hike in toll charges or levying of toll fee in the wake of opening of new toll gates subsequent to the award of the contract. The tenderer should furnish the relevant toll fee receipts to the Union for claiming reimbursement.

Payment of Security Deposit:

40. The successful Tenderer shall execute an agreement with the Union on an Rs.100/- valued Non-judicial Stamp Paper incorporating the terms and conditions of the contract within fifteen days from the date of issue of work order. Each successful Tenderer, before execution of the agreement, payment of security deposit of 5% of the total tender value for transportation of Butter / SMP, shall furnish a Demand Draft from a Nationalized Bank / Scheduled Bank drawn in favor of **General Manager, Trichy District Co-operative Milk Producers' Union Ltd; payable at Trichy** for Hiring of refrigerated insulated Vehicle for transportation of Butter / Hiring of Closed Container vehicle for transportation of SMP. In the event of extension of contract period, the successful Tenderer shall extend the bank guarantee period to the extent of extension of contract period. If the successful Tenderer furnishes Demand Draft, no interest will be paid on the Security Deposit. However, the EMD can be adjusted in the Security Deposit payable and the balance to be remitted. The Security Deposit shall be refunded after six months of the successful completion of the contract or audit / reconciliation whichever is earlier and subject to the production of original receipt.
41. Butter / SMP Vehicle are subject to inspection by the General Manager of the Union or by his authorized representative at any time maximum time allowed for producing the allotted vehicle by the successful Tenderer is 15 days from the date of receipt of Work order. If any defects are noticed at the time of production of vehicle, the same will have to be rectified by the successful Tenderer immediately.

42. If the Butter / SMP vehicle provided by the tenderer are in bad condition / found to be unfit for transportation it shall be disengaged and the tenderer shall make immediate alternative arrangement for Butter / SMP transportation so as to avoid any dislocation in Butter / SMP movement.
43. The successful tenderer should provide only sound vehicle for the contractual work. In case of development of sudden defect and the tenderer should get the vehicle repaired immediately.
44. In case of plying such defective vehicle the tenderer should immediately inform the Union and the tenderer will be paid hire charges less by 5% per trip till it is rectified. However such vehicle should not be used beyond 30 days. If such vehicles are used beyond 30 days, the contract of that vehicle will be terminated, forfeiting the Security Deposit and levying liquidated damages.
45. If the tenderer fails to inform the Union about the use of defective vehicle and if the Union comes to know of that, the Union shall issue notice to the contractor to rectify the defect within 7 days of receipt of notice. If the contractor fails to rectify the defects pointed out within 7 days of receipt of notice, the Union reserves the right to terminate the contract of the vehicle and levy liquidated damages.
46. In case the tenderer could not discharge his contractual obligation because of the above reason and also could not make alternative arrangement for uninterrupted work of transportation of Butter / SMP, the Union would levy penalty and liquidated damages for such failure of the tenderer. The tenderer shall display the following items in size specified by the Union on the Vehicle at their cost.
- (i) 'aavin' logo on front and back.
 - (ii) "On Contract with T.D.C.M.P.U.Ltd". on both the sides of Vehicle
 - (iii) Contractor's mobile number.

47. The Tenderer should remit Rs.10 /- and become the associate member of the Union on awarding of the contract. The amount will not be refunded and the tenderer is not eligible for participating in election or getting the profit.
48. The employees of Federation / District Co operative Milk Producers' Union / Milk Producers' Co operative Society / Milk Consumers Co operative Society / Dairy Development Department or their family members cannot participate in the tender in any form. Family member means, Spouse, Father, Mother, Brother, Sister, Son, Daughter, Grand Father, Grand Mother, Son in Law, Daughter in Law, Grandson and Grand Daughter.

Insurance

49. The tenderer shall arrange for insuring the cost of Butter / SMP transported in his Vehicle (Cargo Insurance).The loss sustained to the Union on account of spoilage of Butter / SMP due to delays in transportation, variance in quality/quantity of Butter / SMP transported due to tampering of seal and other damages occurring to the property of the Union, etc. due to the negligence of the tenderer or his crew, will be recovered from the tenderer.
50. The Butter / SMP vehicle shall not be used for transporting any item including Butter / SMP for other Unions / organizations during their return trip. If any vehicle is found indulging in these activities the contract will be terminated without giving notice.
51. The allotted Butter / SMP Vehicle shall be used for the purpose of Butter / SMP transportation of the Union only. No person other than the driver, attender and the authorized employee of the Union shall be allowed to travel in the Butter / SMP vehicle within the permissible limit prescribed in the MV Act.

52. Payment for the transport bills will be paid on fortnightly basis. The tenderer shall submit bills within three days of the completion of the fortnight. All applicable statutory deductions will be made from the bill. The payment will be made within 15 days from the date of receipt of the bill based on the satisfactory performance of the work.
53. The Butter / SMP vehicle shall be ready for operation for the entire period of contract other than for F.C. repairs for which a maximum of 30 days will be given for getting F.C. During the period of F.C. repairs the tenderer is duty bound to provide alternate vehicle and to ensure that there is no interruption of the scheduled operations, During the period when the permission was availed by the tenderer to garage the Butter / SMP Vehicle, the tenderer should ensure uninterrupted contractual operations by providing substitute conforming to all specifications stipulated in the tender document. There should be no deficiency in service or damage on any count, because of engaging substituted vehicle. In the absence of such substituted vehicle while the contracted REFRIGERATED INSULATED VEHICLE / SMP CLOSED CONTAINER VEHICLE are garaged, the tenderer shall pay to the Union, the loss if any suffered by the Union plus a fine of Rs. 1000/- per day. The request of tenderer seeking permission to garage the REFRIGERATED INSULATED VEHICLE / SMP CLOSED CONTAINER VEHICLE for a period up to 30 days for carrying out fitness certification job will be considered only if the requests are received at least 30 days in advance.
54. The allotted Butter / SMP Vehicle shall not be sold / disposed off or leased out to others during the contract period. However the tenderer is permitted to sell / dispose the allotted refrigerated insulated vehicle / SMP Closed Container vehicle during the contract period after getting prior permission from the general manager of the union, provided he offers an alternative refrigerated insulated vehicle / SMP Closed Container vehicle of similar capacity and age lesser than the tendered Butter / SMP vehicle.

55. The tenderer shall not involve in the sale of milk or milk products either directly or indirectly.
56. The tenderer shall provide replacement of tendered REFRIGERATED INSULATED VEHICLE / SMP CLOSED CONTAINER VEHICLE in case of accident and unforeseen circumstances. In the event of accident / breakdown en route, it is the responsibility of the successful tenderer to make alternative arrangements to decant Butter / SMP from Vehicle and transport Butter / SMP safely to the destination. During this process there should not be any wastage or spoilage of Butter / SMP. In case of wastage / spoilage due to the above event, the loss will be recovered as assessed by the Union from the tenderer.
57. In the above events, the tenderer shall provide replacement for tendered REFRIGERATED INSULATED VEHICLE / SMP CLOSED CONTAINER VEHICLE.
58. The successful tenderer should operate the REFRIGERATED INSULATED VEHICLE / SMP CLOSED CONTAINER VEHICLE in case of necessity as per the agreement beyond tender period up to the time permitted by the TTT Rule 14(9), at the same rate, terms and conditions.
59. The tenderer shall arrange to provide the required number of additional Butter / SMP Vehicle within the limit permitted in the TTT rule 14(9) at required time and at required place as per the direction of General Manager of the Union or his authorized representative at the same contract rate only.

Liability of the contractor towards his employees.

60. The relationship between the Union and the tenderer is one of principal to principal and not one of principal to agent.
61. The tenderer is obliged to discharge the contractual obligation by engaging his own men and materials. The Union will have no connection whatsoever with the men engaged by the tenderer.
62. The tenderer is liable for implementation of all applicable laws including labour laws. The contractor shall register under the EPF Act, and ESI Act etc., The contractor shall furnish the copy of EPF & ESI remittance challans of the previous month towards contribution of EPF & ESI for their employees engaged in Road Milk Tankers along with the second fortnight bill. Without this proof, the second fortnight bill will not be accepted. If the Contractor not registered under the EPF Act and ESI Act or not furnished the proof of remittance of EPF & ESI, the Union shall recover the EPF & ESI contribution from the contractor bills. The contractor shall furnish all the required information and documents whenever the Union calls for the above purpose. If any liability devolves on the Union because of the failure of the contractor in implementing any law, the contractor shall make good the loss and pay damages to the Union.
63. The General Manager of the Union reserves the right to add, subtract and modify any terms and conditions of the agreement with the consent of the Contractor during the contract period.
64. The Union reserves right to accept or reject any or all tenders, retender or cancel the tender as per provisions of TTTT Act and Rules.
65. Further details pertaining to the contract can be obtained from the Union between 10.00 a.m. and 04.00 p.m. on all working days.
66. Sealed tenders shall reach the Union on or before 2.00 p.m on 19.07.2022 and will be opened on the same day in the presence of tenderers/authorized representatives present at 3.00 p.m.
