**4. Eligibility / Qualification criteria:**

- AWBI permitted Animal welfare organization with AWBI recognition number & certificate.
- The Animal welfare organization with at least 3 years experience in ABC-ARC program.
- Animal welfare organization should possess adequate knowledge on Animal welfare without any animal cruelties in the said program and to address the public health issues.
- Well trained veterinary surgeon with professional ethics and surgical skills.
- The agency should not have involved in any crimes or black listed by AWBI/TNAWB/SPCA

**5. Submission of EOI proposal:**

EOI proposal can be submitted along with the Estimated cost per Dog and other required above said documents in a sealed cover addressed to the Commissioner, Madurai Corporation, Arignar Anna Maligai, Madurai-2 in their tender box or through registered / speed post. The EOI should reach the Commissioner office on or before 3 pm of **26.07.2022**

**6. Date & Time of EOI Opening :**

The time of opening of the EOI is 3.30pm of **26.07.2022**, The proposals received after the stipulated date and time shall be rejected.

**7. Evaluation of the EOI proposal:**

The proposals received are evaluated by the Commissioner, Madurai Corporation in the presence of the applicants in his office at 3.30pm of **26.07.2022**. As per the AWBI notifications, the priority is given to the genuine Animal welfare organization with more experiences and performances. The Commissioner, Madurai Corporation reserves the right to accept or reject ANY or ALL EOI's if they are NOT satisfactory.

**8. Memorandum of Understanding:**

The successful outsourcing agency will have to sign the contract agreement with the Commissioner, Madurai Corporation and perform the project as per the terms and conditions mentioned in Memorandum of understanding.

**9. Project Monitoring Committee**

A project Monitoring Committee constituted with Commissioner Madurai Corporation as ex officio Chairman shall monitor and review the project with monthly meeting and time to time instruction given to the Animal welfare organization engaged for ABC-ARV Program of the Madurai Corporation.
