Sealed Pre – Qualification Tenders along with sealed price Tenders are invited for and on behalf of the Governor of Tamil Nadu by the Superintending Engineer, W.R.D., Special Project Circle, Palani.

**4. FOR SPECIAL ATTENTION:**

(i) The contractors registered with TamilNadu State Public Works Department / Water Resources Department under **Class I (State Level) with monetary limit Rs.75.00 Lakhs (Rupees Seventy five Lakhs) and above** and with proven track record of works are eligible.

(ii) The Applicant in the same name and style, should have been in the Civil Engineering Construction field at least for the past FIVE YEARS.

5. The Contractors who fulfill the Pre-qualification criteria are alone eligible to be considered in the Item wise rate system tender.

6. The Pre – qualification tender and Item wise rate price tender in separate sealed envelopes will be received by the **Superintending Engineer., WRD., Special Project Circle, Palani upto 3.00 PM on 27.07.2022.**

**7. PERIOD OF COMPLETION:**

The period of completion shall be **12 (Twelve)** calendar months (including rainy seasons), which is inclusive of monsoon period, from the date of handing over of the site to the successful Tenderer.

## **8. EARNEST MONEY DEPOSIT:**

**8.1 Earnest money deposit of Rs. 2,35,000/- (Rupees One lakh and Thirty Five Thousand only) must accompany with the Pre – Qualification document for this work.**

**8.2 The Earnest money deposit may be produced in the shape of any one of the following forms.**

- (i) Demand Draft issued by Nationalised or Scheduled Banks drawn in favour of the **Executive Engineer, W.R.D., Nanganjiyar Basin Division, Palani.**
- (ii) Small Savings Scripts / Deposits Accounts, KisanVikasPatras duly pledged in favour of the **Executive Engineer, W.R.D., Nanganjiyar Basin Division, Palani.**
- (iii) IndraVikaspatra (at 100% of the Initial Sale value or 50% of the maturity (Face) value.
- iv) Bank Guarantee will not be accepted towards Earnest Money Deposit.
- v) In case of Indira VikasPatras, if the maturity date noted in the patragot lapsed already the same should not be produced.

**8.3 Pre-Qualification tenders not accompanied with the prescribed Earnest Money Deposit and which is not in acceptable shape will be rejected as Non – Responsive tender at the time of opening itself.**

### **9. SECURITY DEPOSIT:-**

**9.a. Successful tender has to furnish security deposit for an amount equal to 2% of the contract value including E.M.D. which will be converted into security deposit.**

**9.b. If the tenderer fails to pay the requisite security deposit amount within the specified period of time, the Earnest Money Deposit paid with the tender will be forfeited.**

**9.c. On evaluation of Tender, if it is found that, over all quoted amount of the Tender is less than 5% to 15% of the value put to Tender, the contractor has also to enclose an additional security deposit at 2% of the estimated value. If the Tender discount exceeds 15% to 20% of the value put to tender the contractor has to enclose an additional security deposit of 50% of the difference between the quoted amount and estimated amount.**

**9(d) If the over all quoted amount of the tender is less than 20% of the value put to tender, then the tender deciding authority will be ascertain the nature of work, the capacity of the tenderer, the competition for this work and feels that this work can be completed by the quoted tenderer with this less value, in such case the contractor has to enclose additional Security Deposit of 50% to the difference between the quoted amount and estimated amount.**

**If the tender deciding authority feels that the quoted contractor will not able to execute the work, in such case the tender will be rejected.**

**The Additional Security Deposit Collected for the minus tenders referred above will be returned only along with security deposit as per agreement condition.**

**9.(e).If the Tender excess exceeds 20% of the value put to tender then the Tender will be rejected.**

**9(f) ADDITIONAL CONDITIONS FOR CONTRACTOR'S SPECIAL ATTENTION.**

1. The contractor is bound for recovery under Revenue Recovery Act for any liabilities under this contract.
  2. "It at any time the Executive Engineer shall be of the opinion that the contractor delaying commencement of the work or violating any conditions of the progress of work, as defined in the tabular statement" rate of progress in the Articles of Agreement" the Executive Engineer will so advise the contractor in writing and at the same time demand compliance. If the contractor neglects to comply with such demand, within 7 days after the receipt of such notice it shall be then or at any time thereafter be lawful for the Executive Engineer to impose penalty or forfeiture on this contractor from the Deposit or to the determine the contract.
  3. "All the rates quoted in the tender, shall be inclusive of sales tax, payable under the General sales tax as amended from time to time to (including amended Act 28/84) and that the contractor is responsible to file the sales tax return and pay the amount of tax as demanded by the C.T. Department. No request for payment of sales tax separately in addition to tendered rates due to any plea of subsequent levy or increase in tax will be entertained vide also clause 38(2) of General conditions to contract.
  4. Any amount fallen due from the contractor on account of this contract even after recovering from the bills for this work and any other contract awarded to the contractor, then the amount is liable to be recovered under the provisions of Revenue Recovery Act.
  5. On evaluation of tender if it is found that if the overall quoted amount of the tender is less than 5% to 15% of the value put to tender, the contractor shall pay an additional security at 2% of the estimated value. If the tenders discount exceeds 15% to 20% the contractor shall pay an additional security deposit of 50% of the difference between the quoted amount and estimated amount. . The tender documents received without the required EMD, and the additional security deposit, as indicated above will be treated as non responsive and Summarily rejected at first instance itself(EICE circular memo No: HDO(A)/13205/2011 dt:5.5.2011.
9. (g). The Security Deposit in the shape of irrevocable Bank Guarantee will also be accepted. The Security Deposit should have a validity period of **49 (Forty Nine)** Months from the date of signing of agreement.
- 9.(h). In addition to the aforesaid security deposit, the Executive Engineer shall deduct from the running account bills, an amount equivalent to **5% ( Five percent)** of the total value of each bill as retention money.
- 9.(i). The Security Deposit shall be released only after **36 Months** reckoned from the date of completion of work.

9.(j). **2 ½ % (Two and a Half Percent)** of the total value of the work, will be retained in the final bill of the work for a period of three year, reckoned from the date of completion of the work or as soon as after the expiration of such period of **36 Months**, as all defects shall have been made good according to the true intent and meaning here of, whichever shall last happen.

9.(k). The Retention money of **2 ½ (Two and a Half Percent)** of the total value of contract after deducting any amount due to the department, shall be refunded to the contractor, after the defects liabilities attached to the contract is over (as per para 9(j) above) subject to the following conditions.

- (i) The Executive Engineer, concerned should certify that no liability is due from the contractor.

#### **10. LANGUAGE OF PRE – QUALIFICATION AND PRICE TENDER :**

Tenders shall be offered only in the prescribed forms in "ENGLISH" only.

#### **11. VALIDITY OF PRICE TENDER:**

The Price tender shall be valid for a period of **90 days (Ninety days)** from the date, notified for opening of price tender.

#### **12. SUBMISSION OF PRICE TENDER:**

12.1 The Price tender under Item wise rate tender System may be submitted as per the instructions given in the price tender Schedule booklet. Tenderer should quote their rates both in figures and words in the Price tender schedule.

12.2. Pre – Qualification tender and Price tender must be submitted separately in a wax sealed envelopes. These envelopes (called as inner envelopes) shall then be put inside, in one outer envelope. The inner and outer envelopes shall be addressed as : **Superintending Engineer, WRD, Special Project Circle, Palani.**

## **INFORMATION AND INSTRUCTION FOR PRE – QUALIFICATION**

### **1. FOR SPECIAL ATTENTION:**

PRE – QUALIFICATION TENDER HEREUNDER IS INVITED IN ACCORDANCE WITH P.W.D., PROCEDURE FOR PRE – QUALIFICATION OF TENDERERS.

### **II. MINIMUM CRITERIA FOR PRE – QUALIFICATION**

**(EIC Circular Memo No. HDO (A) / 18769 / 2009, Dated:12.01.2021)**

#### **Criteria – 1- Registration**

**1.1** The Applicant should be a registered contractor of TamilNadu State Public Works Department/Water Resources Department under **Class I State Level) with monetary limit Rs. 75.00 Lakhs (Rupees Seventy Five Lakhs) and above.**

**Evidence to be produced for 1.1** Attested copy of **Registration Certificate** issued by the Registering Authority, registering the name of applicant as class I Contractor in Tamil Nadu State Public Works Department/Water Resources Department and live list certificate.

**The Applicant in the same "NAME" and STYLE"** should have been in the field of civil Engineering Construction at least for the Past Five Years.

**1.2** If a registered single contractor has changed and registered his / her 'Name and Style' to a Company/ Partnership Firm within the period of past Five Years, is also be considered for this criteria, subject to the condition that the registered individual Contractor is one of the partner and having experience in Civil Engineering / Electrical Engineering filed for at least 5 (FIVE) Years.

**1.3** The applicant should produce evidence with proven track record for his/ her /their Registration and Live Certificate.

#### **EVIDENCE TO BE PRODUCED for 1.2 & 1.3**

(i) Audited Balance sheet with Chartered Accountant's Certificate for the past **"FIVE"** years in the case of Individual Contractor Partnership Firms, Private / Public Limited Companies.

(ii) Attested copy of Registered partnership deed in the case of Partnership Firms.

(iii) Attested copy of Articles of Association and Memorandum of Association registered with Registrar of Companies as per Company Act in the case of Private Limited Companies and Public Limited Companies.

## **Criteria – 2 – Revenue Solvency Certificate:**

**2.1.** The Applicant shall be solvent to an extent **of at least Rs. 30.00 Lakhs (Rupees Thirty Lakhs Only)** on immovable properties in his / her/ firm's name.

**2.2.** In addition to the above, the applicant should furnish the copy of same Solvency Certificate, as furnished to the Registration Authority at the time of registering in his / her / their name, as contractor in PWD/WRD along with the Encumbrance Certificate on that property, which should be authenticated by the Notary Public.

### **EVIDENCE TO BE PRODUCED for 2.1 & 2.2**

(i) Latest Revenue "Solvency Certificates" obtained within six months Prior to the date of tender for **not less than Rs. 30.00 Lakhs (Rupees Thirty Lakhs only)** issued by the Tahsildar concerned.

## **Criteria – 3 - Encumbrance Certificate:**

3.1 The applicant should produce Encumbrance Certificate issued by the Registration Department on the properties listed out in the Solvency Certificate in the name of the applicant for the period from the date of issue of solvency upto the date of publication of tender notice. If it is found that the property owned by the applicant is under mortgaged, the pre-qualification tender is deemed to be invalid.

### **EVIDENCE TO BE PRODUCED for 3**

The Encumbrance certificate issued by the Registration Department on the properties listed out in the Solvency certificate should be produced for the **period from the date of solvency up to the dates between** tender date without any break.

If the date of solvency certificate is within the period of six months before the tender date, the encumbrance certificate need not be produced.

## **Criteria -4- Income tax and GST Certificate**

4.1. The applicant should produce "Income Tax SARAL", as produced to Income Tax Department for the preceding 5 (FIVE) Years, GSTIN (GSTIN or Goods and Services Tax identification number is a unique 15 digit number which has replaced the tax identification number (TIN). Before GST was implemented, dealers registered under the state VAT Law were given a unique TIN by the respective state tax authorities/GSTR (GOOD and Service Tax return) filed copy for the current year.

#### EVIDENCE TO BE PRODUCED for 4

- (i) Attested copy of Income Tax Clearance Certificates or SARAL Form issued by competent Income Tax Department official valid for the current period.
- (ii) The income Tax claimed and paid during the past Five Years and the total contract bill amount received in the past Five years should have been indicated in the Income Tax clearance Certificate.
- (iii) Attested Copy of Registration Certificate showing the GST registration / assigned by the Commercial Tax Department issued by the competent State / Central Commercial Tax Department Officials.
- (iv) GSTIN (GSTIN or Goods and Services Tax Identification Number is a unique 15- digit Number, which has replaced the Tax Identification Number (TIN). Before GST was implemented, dealers registered under the State VAT Law were given a unique TIN by the respective State Tax Authorities)/ GSTR (Goods and Service Tax Return) filed copy for the current year.

#### **Criteria – 5 – Major Works:**

5.1. The applicant should produce the documentary evidence for the constructed and completed major works by him / her / them during the past 5 (Five) Years.

#### EVIDENCE TO BE PRODUCED for 5

List of major Civil Construction works, completed in the **past five years** with full and complete details such as

- (i) Name of work
- (ii) Value of work
- (iii) Name of Employer for whom the works were executed
- (iv) Agreement Number
- (v) Period of Completion as per agreement
- (vi) Actual period of execution and date of completion.
- (vii) Reasons for delay if any.
- (viii) Nature of works.
- (ix) Certificate issued by employer.

Certificate for Civil works with break up details should be produced.  
(Details furnished without supporting certificates will not be considered)

#### **Criteria – 6 – Similar Nature of Single Work Within Preceding 5 Years:**

The applicant should have satisfactorily completed at least-

- i) One work of similar nature with value not less than **Rs. 225.00 Lakhs** in a single agreement in any one of the preceding 5 (FIVE) years.

(or)

- ii) Two works in two agreements of similar nature with value not less than **Rs.112.50 Lakhs** contract value in any one of the preceding 5 (FIVE) Years.

\*\* The value of single similar nature of works executed shall be brought at current price level with the cumulative weightage at a rate of 10% per annum.

### EVIDENCE TO BE PRODUCED for 6

For Non-Government works of similar nature executed by the tenderer externally for private parties, shall also be considered, provided that, the tenderer should produce an Affidavit authenticated by the Notary Public with regard to the private works completed by him/her/them other than Government / Quasi Government Organizations.

- I. In addition to the above, the concerned Executive Engineer, WRD., under his / her jurisdiction, shall issue a genuineness Certificate for the private work executed by the applicant, after his/her personnel inspection and based on local enquiry.
- II. The Tender Inviting Authority shall verify, satisfy and confirm the certificate issued by the Executive Engineer for the private work executed by the applicant, whether the contract amount has been reflected in the Assessment Year of the Income Tax Statement of the applicant. The Quantity of works should have been executed in any one year during the last five years. The applicant will supply information regarding annual production for these items in the set of forms enclosed (form D4) with necessary certificate from the Engineer – in – Charge Certifying the specified items of works, executed in any one year in the last 5 years.

**Criteria – 8 - ANNUAL FINANCIAL TURNOVER:**

8.1. Annual turnover of the applicant shall be not less than **Rs. 675.00 Lakhs (Rupees Six Hundred and Seventy Five Lakhs only)** in any one of the preceding " Five" years.

**EVIDENCE TO BE PRODUCED for 8**

(i) Audited Balance Sheet, Profit and Loss Account etc., duly certified by the Chartered Accountant for the preceding "**FIVE**" Years.

(ii) With the condition that total amount of contract received by the applicant from the Employer / Employers should have been reflected in the ITCC also.

(iii) In case of difference in the depicted contract amount of the balance sheets and the amounts furnished in the Income Tax clearance certificate, the lesser of the two figures would be reckoned with.

9.1. The applicant should have a minimum of issued / called up "Share Capital" and "Capital Reserves" equal to **Rs. 90.00 Lakhs (Rupees Ninety Lakhs only)**

9.1. The applicant shall have required working capital for at least **Rs.37.50 Lakhs** under assumption that if the work under reference is also awarded to him / her / them.

9.2. Working capital means the amount available in the bank accounts of the applicant on the date of submission of Pre – Qualification application (Plus) un utilised amount of overdraft / credit facilities readily to extend to the applicant for the particular work issued by the Nationalised / Scheduled Banks approved by Reserve Bank of India.

9.3. One month current activity means, sum of total value of the unfinished portion of works already committed by the applicant and the work being executed (outstanding value) **divided** by the balance period available for completion of each of the committed works under execution **plus** value of work for which the Pre – Qualification application is called for divided by the number of months stipulated for its completion.

9.4. Outstanding value of committed works means, the total value of each project under execution **minus** the value of work completed plus work ready to commenced (i.e. committed work) as on the date of submission of Pre- Qualification application.

9.5. Regarding the working capital required, the certificate obtained from the Bank shall be IN ORIGINAL.

9.6. If it is found by the Tender Inviting Authority that, the applicant has furnished the incorrect particulars, the forged/false information (or) Incomplete particulars (or) incorrect details of ongoing works/ committed works by him / her / them in the Pre-Qualification application, the Pre –Qualification application may be treated as substantially non – responsive and rejected, as per the rules framed under Section-28 of Chapter -6 of Tamil Nadu Transparency in Tenders Rules,2000.
