Dear Bidders.

Sealed tenders are invited by NCC Group Headquarters, Madras 'A' on behalf of NCC Directorate (TN, P & AN) hereinafter referred as "Govt / Purchaser" from Vendor / Bidder / Supplier / Contractor hereinafter referred to as "Bidder / Tenderer" for purchase of uniform and Accoutrement items for NCC Cadets selected to represent NCC Directorate (TN, P & AN) at TSC, New Delhi in September 2022. The details of items required along with quantity are attached as Appendix 'A'.

2. Scope of Tender:

- (i) Obtain measurement of cadets and contingent staff at Chennai for stitching of Uniform and Blazer before 12 Aug 2022.
- (ii) Supply of items less uniforms and blazer on or before 10 Aug 2022.
- (iii) Stitching and refitting of uniform and blazers per Appendix 'A' and delivery at Chennai on or before 05 Sep 2022.
- (iv) Positioning of minimum of two tailors at Chennai for a min period of 10 days for refitting of uniform and blazer from the period intimated by the Group HQ, Madras 'A' / Kitting Officer.
- 3. <u>Timeline:</u> Besides quality, timely delivery of items as Appendix "A" is of paramount importance and hence the Bidder is clearly notified that suitable penalty charges would be levied because of late delivery. The detail of penalty clause is dealt separately at "Terms and Conditions" at Appendix "B".
- 4. <u>Eligible Bidder:</u> Eligible Bidder will be the one who satisfies the following conditions:-
 - (a) Not black listed or under process of being black listed by an of NCC Group Headquarters / Directorate across India.
 - (b) Has at least three years of experience kiting NCC cadets for TSC/RDC. Proof to be provided along with the bids.
 - (c) <u>Regular Tax-Payer:</u> Income-Tax verification certificate in the prescribed from from the Income-Tax Offices of the Circle Ward of District where he is assessed or assessable to income-tax.
 - (d) GST registered vendor.

5. Two-Bid System

- (a) Under the two-bid system, all Bidders are requested to quote for Technical bid and Commercial bid separately in two different envelopes. The two envelopes will be super scribed in BOLD and in RED colour as "Quotation for TSC-2022-Technical-Bid" and "Quotation for TSC-2022-Commercial Bid". Both the envelopes along with the covering letter and other necessary documents will put in a single sealed envelope and deposited at Group Headquarters, Madras 'A' either by Post or by hand before the expiry of due date and time.
- (b) The format of technical bid is attached as Appendix "C", while quoting in the technical bid, compliance for brand name explicitly specified in the tender only be given and any attempt to include any other brand not asked for would result in summary rejection of tender. Technical bid WILL NOT contain any reference to cost.
- (c) The format for commercial bid is given at Appendix 'D'. Rates of items to be quoted both in figures and words in **English language only.** Wherever discrepancy is noticed between the two rates, the amount in words will be considered as final. Any erasure, cutting and overwriting will be duly authenticated by the person responsible for tender and with business stamp. The commercial bid will include GST as applicable.
- 6. <u>Tender Details:</u> Tender document is available for download for free of cost from website <u>www.tn.tender.gov.in</u>. If application is collected personally from Administrative Officer, NCC Group Headquarters, Madras 'A' or required by post the cost of application is Rs.250/- payable through Demand Draft.

 - (b) <u>Last Date:</u> Last Date of Receipt of Tender at above mentioned address is 28 Jul 2022, 1030hrs. Tender can be submitted by post or can be dropped in person on or before due date. Late receipt of tender even due to postal delay will not be accepted.
 - (c) <u>Tender Box:</u> One Tender box being placed at Group Headquarters, Madras 'A' premises from 12 / 13 Jul 2022 for receiving tenders. The tender box would be available for submission of bids between 1030hrs to 1645hrs on all working days. On 28 Jul 2022, tender box would be available only from 0900hrs to 1000hrs.
- 7. <u>Date of Opening of Technical and Commercial Bid:</u> Tenders will be opened on 28 Jul 2022, 1100hrs at office location of NCC Group HQ, Madras 'A', Tamil Nadu. <u>All Bidders/ representative are requested to be present on 28 Jul 2022 latest by 1100hrs along with all the samples proposed to be supllied as list attached as <u>Appendix 'A'</u>. Representatives are required to bring Identity Card and Authority Letter from the owners / Company, without which they will not be permitted to participate in the bid. Technical Bids without samples will be rejected.</u>

- 8. <u>Initially Technical Bids will be opened and samples will be checked. Only those vendors who have qualified in the Technical Bid, their Commercial Bids will be opened.</u>
- 9. The Board of Officers constituted for opening of tender and for deciding the award of tender reserves the right of rejecting any tender without assigning any reason what so ever and the decision in the matter will be final. The lowest tender may not necessarily be accepted.
- 10. Price Negotiation Committee (PNC) PNC will be held at NCC Directorate (TN, P & AN), Fort St George, Chennai 09 on 29 Jul 2022. The approved / selected bidder should be present on the day at NCC Directorate, Chennai for finalization of tender and award of contract. No representation in this regard will be accepted.

11. Financials:

- (a) <u>Tender Value</u> As permarket survey undertaken and previous years tendered cost, the indicative approx value of the tender is around Rs.9.5 lakhs.
- (b) <u>EMD</u>: The Tenderer shall be required to provide an Earnest Money Deposit (EMD) Rs.19,000/- (Rupees Nineteen thousand only), which is 2% of the project cost of Rs.9.5 lakhs while submitting the bid. EMD which shall be in the form of Demand Draft or Banker's Cheque drawn in favour of NCC Group Headquarters, Madras 'A' payable at Chennai. Earnest Money Deposit shall be forfeited if the tenders withdraw his tender after submission of bid but before opening of tender or following the opening of tender, withdraws its tenders before expiry of the period of effectiveness of the tender.
- (c) Bids without the EMD will be summarily rejected. Claim for exemption from submission of EMD will not be entertained for whatsoever reason it may be.
- (d) The EMD of tenderers who have not been selected will be released not later than 60 days after the expiration of the tender validity period.
- (e) EMD of the selected / approved vendor shall be discharged when the tenderer furnishes the required Performance Security.
- (f) <u>Peformance Security Deposit</u> The Performance Security Deposit at the rate of 5% of the project value is to be paid by means of Demand Draft / Banker's Cheque drawn in favour of NCC Group Headquarters, Madras 'A' payable at Chennai, will be submitted on award of the contract. No other mode of payment is being accepted.

TERMS AND CONDITIONS

- 1. Eligible Bidder: Eligible bidder will be the one who satisfies the following condition:-
 - (a) Not a black listed or under process of being black listed by any of NCC Gp HQ / Dte across India.
 - (b) Has at least three years of experience kitting NCC Cadets for TSC / RDC. Proof to be provided along with the bids.
 - (c) Regular Tax Payer: Income-Tax verification certificate in the prescribed form from the Income-Tax Offices of the Circle Ward or District where he is assessed or assessable to Income-Tax.
 - (d) GST Registered Vendor
- 2. High Standard of workmanship, quality of material and timely supply are the prime requisite of the supply.
- 3. The tenderer shall submit his bid in two parts namely Technical and Commercial bid in two separately sealed envelopes. Taxes incl GST etc as applicable will be included separately in the commercial bid.
- 4. Each bid must be accompanied with samples of all materials asked in the Appx 'A' in a sealed cardboard box duly pasted with his firm's seal/letter head on top of box.
- 5. All items, which are not supplied as per samples, order are liable to be rejected at the discretion of Board of Officers. Accepted samples during the opening of Tender will be retained for quality checking by the NCC Gp HQ, Madras 'A', till completion of the camp. It is the vendor's responsibility to collect the samples from NCC Gp HQ, Madras 'A'.
- 6. No increase in price because of any statuary increase in or fresh imposition of custom duty, excise duty, GST or duty levied in respect of stores will be accepted once the bid is submitted.
- 7. The tender rates will be valid up to 31.12.2022 for all quantities as mentioned in Appx 'A'.
- 8. The decision to accept fully or in part or reject a tender in full or part finally rest with the Tender opening Board of Officers.
- 9. On award of the contract, the acknowledgement of supply order should be furnished within seven days of receipt of the supply order. Non-acceptance of supply order will result in non-refund of security deposit at the rate of 5%.
- 10. The delivery of all items must be completed by 05 Sep 2022 at NCC Group Headquarters, Madras 'A'. The supplier has to ensure fitting of all clothing items at camp site. No separate transport charge will be paid.

- 11. The Board of Officers detailed by NCC Group Headquarters, Madras 'A' will carry out inspection of stores being supplied by the bidder as well as monitor the quality of stitching being carried out.
- 12. The Kitting Officer, NCC Group HQ, Madras 'A', has the authority to change the quantity of items demanded as per requirement at a later date. Since the quality of the kitting items ais prime important, eve if, the bidder is selected as L1 Vendor as pe rate, contract will be given to L2 and L3 Vendor, if their quality of products / kitting items are of high standard. The kitting Officer is empowered to change the Vendor based n the quality of kitting items in partial or complete items.

13. Liquidated Damages:

- (a) For late delivery of items Part or full later than 10 Sep 2022 but earlier than 25 Aug 2022. 5% of the contracted value for each full day. The amount will be deducted from the amount due to the Bidder.
- (b) For late delivery of items Part or full from 10 Sep 2022: The items will be brought at market price at Chennai and the amount will be deducted from amount due to the Bidder. The Bidder is liable to pay extra amount more than the contracted amounted in view of the risk purchase.

14. Arbitration Clauses:

- (a) All disputes arising between the partners as to the interpretation, operation or effect of any clause in this tender document or any other difference arising between the Bidder and the NCC Gp HQ, Madras 'A' which cannot be mutually resolved, shall be referred to the arbitration of Gorup Commander (Arbitrator 1), NCC Gp HQ, Madras 'A'. Failing him, DDG, NC Dte, TN,P&AN, Chennai will be the final arbitrator and whose decision shall be binding on both the parties.
- (b) All disputes will be resolved at Chennai / TN State only.
- 15. Warranty and Guarantee: The stores supplied under this order / tender shall be deemed warranted by this contractor against defective material, workmanship, finish and performance for the period for at least three months from the date of receipt of the stores. In case stores supplied are found defective, same shall be replaced immediately as per approved samples by the bidder at his risk and cost.
- 16. All stores will be supplied to the camp site at Chennai or the place to be intimated by NCC Gp HQ, Madras 'A' by the contractor under his own arrangement. No extra transportation cost will be given or item will be collected from any other station.
- 17. The process of the final payment of bills may take from one of two months on completion of camp.
