Sealed Pre – Qualification Tenders along with sealed price Tenders are invited for and on behalf of the Governor of Tamil Nadu by the **Superintending Engineer**, **WRD.**, **Periyar Vaigai Basin Circle**, **PWD Campus**, **Tallakulam**, **Madurai** – **625002**.

4. FOR SPECIAL ATTENTION:

- (i) The contractors registered with TamilNadu State Water Resources Department / Public Works Department under <u>Class I (State Level) with monetary limit Rs.75.00 Lakhs and above (Rupees Seventy five Lakhs and above)</u> and with proven track record of work are eligible.
- (ii) The Applicant in the same name and style, should have been in the Civil Engineering Irrigation Construction field atleast for the past FIVE YEARS.
- 5. The Contractors who fulfill the Pre-qualification criteria are alone eligible to be considered in the Item wise rate system tender.
- 6. The tender in outer sealed envelope contains pre-qualification tender and item wise price tender in separate inner sealed envelopes will be received by the Superintending Engineer, WRD., Periyar Vaigai Basin Circle, PWD Campus, Tallakulam, Madurai 625002 upto 3.00 P.M. on 12.08.2022.

7. PERIOD OF COMPLETION:

The period of completion shall be **12** (**Twelve**) calendar months, which is inclusive of Monsoon period, from the date of handing over of the site to the successful Tenderer.

8. EARNEST MONY DEPOSIT:

- 8.1 Earnest money deposit of **Rs. 2,37,000/- (Rupees Two Lakhs and Thirty Seven Thousand only)** must accompany with the Pre Qualification document for this work.
- 8.2 The Earnest money deposit may be produced in the shape of any one of the following forms.
 - (i) Demand Draft issued by Nationalised or Scheduled Banks drawn in favour of the Executive Engineer, W.R.D., Periyar Main Canal Division, Melur
 - (ii) Small Savings Scripts / Deposits Accounts, Kisan Vikas Patras duly pledged in favour of the Executive Engineer, W.R.D., Periyar Main Canal Division, Melur
 - (iii) Bank Guarantee will not be accepted towards Earnest Money Deposit.
- 8.3 Pre-Qualification tenders not accompanied with the prescribed Earnest Money Deposit and which is not in acceptable shape will be rejected as Non Responsive tender at the time of opening itself.

9. SECURITY DEPOSIT:-

- 9.a. Successful tenderer has to furnish security deposit for an amount equal to **2**% **of the contract value including E.M.D**. which will be converted into security deposit.
- 9.b. If the tenderer fails to pay the requisite security deposit amount within the specified period of time, the Earnest Money Deposit paid with the tender will be forfeited.
- 9.c. On evaluation of Tender, if it is found that, over all quoted amount of the Tender is less than 5 to 15% of the value put to Tender, the contractor has to pay an additional security deposit at 2% of the estimated value. If the Tender discount exceeds 15% to 20% of the value put to tender the contractor has to pay an additional security deposit of 50% of the difference between the quoted amount and estimated amount.

9(d) If the over all quoted amount of the tender is less than 20% of the value put to tender, then the tender deciding authority will be ascertain the nature of work, the capacity of the tenderer, the competition for this work and feels that this work can be completed by the quoted tenderer with this less value, in such case the contractor has to pay additional Security Deposit of 50% to the difference between the quoted amount and estimated amount.

If the tender deciding authority feels that the quoted contractor will not able to execute the work, in such case the tender will be rejected.

The Additional Security Deposit Collected for the minus tenders referred above will be returned only along with security deposit as per agreement condition.

- 9. e.Failure to furnish the additional security deposit within 15 days from the date of receipt of acceptance order and execute the agreement shall entail cancellation of award of contract and forfeiture of E.M.D. furnished.
- 9.f. The Security Deposit in the shape of irrevocable Bank Guarantee will also be accepted. The Security Deposit should have a validity period of **25 (Twenty Five)** Months from the date of signing of agreement.
- 9.g. In addition to the aforesaid security deposit, the Executive Engineer shall deduct from the running account bills, an amount equivalent to 5% (Five percent) of the total value of each bill as retention money.
- 9.h. The Security Deposit shall be released only after **12 Months** reckoned from the date of completion of work certified by the Engineer.
- 9.i. 2 ½ % (Two and a Half Percent) of the total value of the work, will be retained in the final bill of the work for a period of one year, reckoned from the date of completion of the work or as soon as after the expiration of such period of 12 Months, as all defects shall have been made good according to the true intent and meaning here of, whichever shall last happen.
- 9.j. The Retention money of 2 ½ (Two and a Half Percent) of the total value of contract after deducting any amount due to the department, shall be refunded to the contractor, after the defects liabilities attached to the contract is over (as per para 9(i) above) subject to the following conditions.
 - (i) The Executive Engineer, concerned should certify that no liability is due from the contractor.

10. LANGUAGE OF PRE - QUALIFICATION AND PRICE TENDER:

Tenders shall be offered only in the prescribed forms in "ENGLISH" only.

11. VALIDITY OF PRICE TENDER:

The Price tender shall be valid for a period of **90 days (Ninety days)** from the date, notified for opening of price tender.

12. SUBMISSION OF PRICE TENDER:

- 12.1 The Price tender under Item wise rate tender System may be submitted as per the instructions given in the price tender Schedule booklet. Tenderer should quote their rates both in figures and words in the Price tender schedule.
- 12.2. Pre Qualification tender and Price tender must be submitted separately in a wax sealed envelopes. These envelopes (called as inner envelopes) shall then be put inside, in one outer envelope. The inner and outer envelopes shall be

1. FOR SPECIAL ATTENTION:

PRE - QUALIFICATION TENDER HEREUNDER IS INVITED IN ACCORDANCE WITH P.W.D., PROCEDURE FOR PRE - QUALIFICATION OF TENDERERS.

II. MINIMUM CRITERIA FOR PRE - QUALIFICATION

1. ELIGIBILITY AND REGISTRATION

1 (a) The Applicant should be a registered contractor of TamilNadu State Water Resources Department / Public Works Department under <u>Class I</u> (State Level) with monetary limit Rs. 75.00 Lakhs and above (Rupees Seventy Five Lakhs and above).

Evidence to be produced for 1 (a)

Attested copy of **Registration Certificate** issued by the Registering Authority, registering the name of applicant as class I Contractor in Tamil Nadu State Public Works Department/Water Resources Department and live list certificate.

1 (b) The Applicant in the same "NAME" and STYLE" should have been in the field of civil Engineering Irrigation Construction at least for the Past Five Years.

Evidence to be produced for 1 (b)

- (i)Audited Balance sheet with Chartered Accountant's Certificate for the past "FIVE" years in the case of Individual Contractor Partnership Firms, Private / Public Limited Companies.
- (ii) Attested copy of Registered partnership deed in the case of Partnership Firms.

- (iii) Attested copy of Articles of Association and Memorandum of Association registered with Registrar of Companies as per Company Act in the case of Private Limited Companies and Public Limited Companies.
- 1 (c). If a registered single contractor has changed and registered his / her 'Name and Style' to a Company / Partnership Firm within the period of past Five Years, is also be considered for this criteria, subject to the condition that the registered individual contractor is one of the partner and having experience in Civil Engineering field for at least 5 (Five) Years.

Evidence to be produced for 1 (c)

The applicant should produce evidence with proven track record for his / her / their Registration and Live Certificate.

2. REVENUE SOLVENCY CERTIFICATE:

- 1. The applicant should be solvent to a tune of at least **Rs.30.00 lakhs** (higher value may be fixed by the Tender Inviting Authority based on the value of work for which tenders are floated) on immovable properties in his / her / their name obtained from Revenue Authorities.
- 2. In addition to the above, the applicant should furnish the copy of same Solvency Certificate, as furnished to the Registration Authority at the time of registering in his / her / their name, as contractor in PWD along with the Encumbrance Certificate on that property, which should be authenticated by the Notary Public.
- 3. If any ambiguity noticed by the Tender Inviting Authority while scrutinising the pre-qualification tender application With regard to the Solvency Certificate furnished by the contractor in the pre-qualification document and at the time of registration, as a contractor in PWD, is varied, the Tender Inviting Authority may seek clarification with the Registration Authority and verify its genuineness'

since the initial Solvency Certificate furnished by the applicant at the time of registration, as contractor in PWD is the fundamental document for registration.

EVIDENCE TO BE PRODUCED for 2

The solvency of the applicant shall be evidenced by the production of certificate of Revenue Solvency (In India) on immovable properties to the tune of Rs.30.00 Lakh issued by the Tahsildar of the taluk concerned with latest Encumbrance certificate.

3. ENCUMBRANCE CERTIFICATE:

The applicant should produce Encumbrance Certificate issued by the Registration Department on the properties listed out in the Solvency Certificate in the name of the applicant for the period from the date of issue of solvency upto the date of publication of tender notice. If it is found that the property owned by the applicant is under mortgaged, the pre-qualification tender is deemed to be invalid.

4. INCOME TAX AND GST CERTIFICATE

The applicant should produce "Income Tax SARAL", as produced to Income Tax Department for the preceding 5 (Five) Years, GSTIN [GSTIN or Goods and Services Tax Identification Number is a unique 15-digit Number, which has replaced the Tax Identification Number (TIN). Before GST was implemented, dealers registered under the State VAT Law were given a unique TIN by the respective State Tax Authorities] / GSTR (Goods and Service Tax Return) filed copy for the current year.

- i). An attested copy of the Income Tax clearance certificate / Income Tax Assessment order issued by the competent Income Tax departmental official shall be produced.

6. SIMILAR NATURE OF SINGLE WORK WITHIN PRECEDING 5 YEARS

The applicant should have satisfactorily completed at least one Irrigation works of similar nature with value not less than Rs. 226.09 Lakhs (Rupees Two Hundred and Twenty Six Lakhs and Nine Thousand only) under a single agreement in any one of the preceeding "Five" years at 2022 -2023 price level.

- i. One work of similar nature with value not less than 50% of proposed contract in a single agreement in any one of the preceding 5 (Five) years.
- ii. Two works in two agreements of similar nature with value not less than 25% (each work) of proposed contract value in any one of the preceding 5 (Five) years.
- iii. For Non-Government works of similar nature executed by the tenderer externally for private parties, shall also be considered, provided that, the tenderer should produce an Affidavit authenticated by the Notary Public with regard to the private works completed by him / her / them other than Government / Quasi Government Organisations.

iv. Weightage at 10% per annum will be allowed to bring the value of work to the current year value.

ii. In addition to the above, the concerned Executive Engineer, PWD under his / her jurisdiction, shall issue a genuineness certificate for the private work executed by the applicant, after his / her personnel inspection and based on local enquiry.

iii. The Tender Inviting Authority shall verify, satisfy and confirm the certificate issued by the Executive Engineer for the private work executed by the applicant, whether the contract amount has been reflected in the Assessment Year of the Income Tax Statement of the applicant. The same should be furnished along with prequalification tender proposal for consideration by the Tender Accepting Authority.

7. ANNUAL FINANCIAL TURN OVER

Annual turn over of the applicant shall be not less than Rs. 678.27 Lakhs (Rupees Six Hundred and Seventy Eight Lakhs and Twenty Seven Thousand only) in any one of the preceding "Five" years.

EVIDENCE TO BE PRODUCED: for (7)

(i) Audited Balance Sheet, Profit and Loss Account etc., duly certified by the Chartered Accountant for the preceeding "FIVE" Years.

(ii) With the condition that total amount of contract received by the applicant from the Employer / Employers should have been reflected in the ITCC also.

(iii) In case of difference in the depicted contract amount of the balance sheets and the amounts furnished in the Income Tax clearance certificate, the lesser of the two figures would be reckoned with.

8. SHARE CAPITAL

The applicant shall have Share capital to a value of Rs. 90.44 Lakhs (Rupees Ninety Lakhs and Forty Four Thousand only)

(The applicant should have a minimum of issued / called-up share capital and the capital reserves equal to at least 20% of the value of work for which the prequalification tender have been called for)

9. WORKING CAPITAL

The applicant shall have working capital to a value of Rs. 37.68 Lakhs (Rupees Thirty Seven Lakhs and Sixty Eight Thousand only)

DEFINITION:

a) The applicant shall have required working capital for at least sufficient tofinance for one month current activity (including all ongoing works in hand and works awarded and to be commenced) under assumption that if the work under reference is also awarded to him / her / them.

- b) Working capital means the amount available in the bank accounts of the applicant on the date of submission of pre-qualification application (plus) unutilised amount of overdraft / credit facilities readily to extend to the applicant for the particular work issued by the Nationalised / Scheduled Banks approved by Reserve Bank of India.
- c) One month current activity means, sum of total value of the unfinished portion of works already committed by the applicant and the works being executed (outstanding value) divided by the balance period available for completion of each of the committed works under execution plus value of work for which the pre-qualification application is called for divided by the number of months stipulated for its completion.
- d) Outstanding value of committed works means, the total value of each project under execution minus the value of work completed plus works ready to commenced (i.e. committed works) as on the date of submission of pre-qualification application.
- e) Regarding the working capital required, the certificate obtained from the Bank shall be **IN ORIGINAL.**
- f) If it is found by the Tender Inviting Authority that, the applicant has furnished the incorrect particulars, the forged / false information (or) incomplete particulars (or) incorrect details of ongoing works / committed works by him / her / them in the pre-qualification application, the pre-qualification application may be treated as substantially non-responsive and rejected, as per the rules framed under Section-28 Of Chapter-6 of Tamil Nadu Transparency in Tenders Rules, 2000.

The applicant shall have a Project Manager together with site Engineer with degree in Civil Engineer, Diploma in Civil Engineering with minimum field experience noted against each, available as given below, exclusively for this work.

The applicant should furnish an affidavit authorised by the Notary Public for the Technical personnel available with him / her / them (or) proposed to be engaged especially for this work with him / her / them along with their consent letter and qualification certificate and certify their experience in the field.

Numbers and qualification of the Technical Personnel has to be decided by the Tender Inviting Authority based on the requirements of each work especially for the specialised nature of work like heritage nature of Works

with minimum three years experience.
