#### **4.GENERAL TERMS AND CONDITIONS:**

- 4.1 The TWO PART TENDER for the Operation and Maintenance of Sachet Machines in Vellore Dairy On Contract Basis for the Year 2022-2023 consists of:
  - a) i) PART-I TECHNICAL BID, wherein, the pre-qualification, based on various factors Such as (I) Having minimum two years experience in operation and Maintenance of Milk packing Sachet Machines. (2) Qualified Technician. (3) proof of Bank account with minimum balanceof Rs 50,000/-. (4) E.P.F & E.S.I. Registration Certificates (5) Remittance of Rs 48,000/-as EMD amount will be evaluated, considered and decided prior to opening and consideration of commercial Bid under PART-II of the tender Terms and conditions pertaining to the nature of work, which is enclosed with this Tender should be followed.
    - ii) The PART-I technical bid shall be opened on the date/time and venue specified in the presence of the tenderers of their authorised representative who opt to be present during the opening.
  - b) i) The PART-I Commercial Bid of the tenderers who do not satisfy any/all the terms and Conditions specifically so mentioned under PART-I Technical Bid shall not be considered for eligible and their Commercial Bid Part II Tender shall not be opened.
    - ii) PART-II Commercial Bid, wherein the rates tendered by those who qualify themselves for and are selected based on the lowest and negotiated rates and as per the terms and conditions prescribed in PART-I TECHNICAL BID only will be considered and decided for the award of the contract.
  - (iii) The above finally selected tenderer shall execute an agreement on Non-Judicial stamp Paper for the value of Rs.100/- due and faithful performance of the contract at the tendered rates which shall be valid for 12 months from the date of issue of Order/execution of agreement.
- 4.2 THE PART-II Commercial bids shall be opened on completion of the Part-I Pre-Qualification/technical bids in the presence of tenderers or their authorised representative who opt to be present. The date of such opening of commercial bid will be informed separately to those who qualify in the PART- I Technical bid

- 4.3 Tenders received after the specified date and time shall be summarily rejected.
- 4.4 The Tender forms are not transferable or assignable.
- 4.5 The signatory of the tenderer should indicate his/her/their status in which he/she/they have signed and submit necessary Legally/Lawfully admissible documentary proof in respect of such authority assigned to him/her/them by the firm. If the tender opening day is declared as holiday, the tenders shall be received and opened immediately on the next working day at the same time and place.
- 4.6 1. All tenders must be accompanied with the prescribed amount of E.M.D. along with the tender as specified in the Condition 4.6.2.
- 4.6.2. EMD. Payable shall be Rs.48,000/- by means of Bank Draft from any Nationalised Bank drawn on or before 02 -08-2022 in favour of the "General Manager Vellore District Co-operative Milk Producers Union Ltd." payable at Vellore. It shall be enclosed with the part-I Technical Bid. No other form of remittance shall be accepted and Tender will be rejected.
- 4.6.3 Should the tenderer withdraw his/her offer before finalisation of the tender the EMD. remitted by the tenderer shall be forfeited in full.

#### 4.7 DOCUMENTS TO BE FURNISHED

- 4.7.1 Tenderers are expected to furnish the Photostat copies of documents as noted below along with the Tender (Technical Bid).
- Having handled Operation and Maintenance of packing machines work for a period of two years in packing of Milk in reputed Dairies or Co-operative Unions
- 2) Should have the proof of Bank account which have a minimum bank balance of Rs.50000/-.

- 1) E.P.F., E.S.I or equivalent Government Registration Certificates and Income Tax Certificate and PAN.
- 2) Remittance of Rs.48,000/- as Earnest Money Deposit either by D.D. or in the Office Cash receipt.

#### 4.8.0 SECURITY DEPOSIT:

- 4.8.1 After evaluation and finalization of pre-qualification-cum Technical bids and Commercial bids, selected tenderers would be required to furnish a security deposit of 5% of the entire value quoted additionally by means of Demand Draft from any Nationalized Bank drawn in favour of "General Manager, Vellore District Co- Operative Milk Producers Union Ltd., Vellore" payable at Vellore within 15 days from the date of awarding the contract which will bear no interest.
- 4.8.2 For the selected Tenderers the EMD. paid shall be converted as Security Deposit and retained with the Union for the due and faithful performance of the contract. EMD will be refunded for other un-successful tenderers.
- 4.8.3 No interest shall be paid on the Earnest Money Deposit or Security Deposit.

#### 4.9.0 AGREEMENT:

After evaluation and finalisation of pre-qualification / technical bids and Commercial bids, selected tenderers would be required to sign an agreement in Rs.100/- non-judicial stamp paper and return the same within 15 days of receipt of the work order or submission of first claim bill whichever is earlier.

4.10.0 If the tenderer fails to execute the work satisfactorily as per the scope of work and terms and conditions, the necessary penalty will be imposed. If such lapses are repeated three times, the contract awarded shall be cancelled in full and amount equivalent to double the actual loss incurred shall be recovered and S.D. forfeited.

#### **VIOLATION OF CONTRACT:**

Not with-standing anything contained in the tender schedule, no obligation is cast on the Union to accept the lowest tenderer and the Union shall also have the right to accept or reject the tender without assigning any reasons.

4.10.2 For violation of any of the Terms and Conditions of the contract, the Union reserves the right to terminate the contract, with or without notice, as applicable.

In the event of termination of contract, the S.D. will be forfeited and any of the resultant loss shall be recovered.

#### 4.11.0 DISPUTES AND ARBITRATION:

In case of disputes arising out of this tender, an Arbitrator as mutually acceptable

Tenderer and Union will be appointed. The Arbitrator's decision shall be final, conclusive and binding on both the parties.

#### 4.12.0 LEGAL JURISDICTION:

In case if either party to the tender is aggrieved by the award of the Arbitrator so appointed as per clause 4.11.0 or otherwise, they can appeal to Court. The Courts situated in Vellore alone shall have jurisdiction to entertain such disputes.

#### **5.0 PAYMENT TERMS:**

- 5.1.0 The Contractor shall submit necessary monthly invoice in duplicate along with advance stamped receipt and performance report shall get certificate from concerned Dairy Officials for making payments.
- 5.2.0 The payment shall be made within 15 days from the date of receipt of the bills on satisfactory performance, after deducting the statutory recoveries and other service/materials cost given by the Union

#### 6. PRE-QUALIFICATION- GENERAL TERMS AND CONDITIONS:

The Pre-qualification tender/part-I Technical bid will contain the under mentioned aspect pertaining to the prospective contractor about their suitability, capacity, Financial Status, Past performance etc.

The conditions are:

- 6.1 The Tenderer should have a previous experience record of having executed similar work to any of the reputed Dairies have more than 1 Lakh Litres sales per day or Co- operative Unions and submit records along with clientele list in part-I Technical bid
  - 6.2 The tenderer should have the capacity of providing Two (2) Technical /per shift( minimum ITI qualification awarded by Central/state Government approved institutions ) persons with one unskilled manpower per shift for the Operation and Maintenance of High speed prepac Sachet Machines for three shifts daily as per our requirement.
  - 6.3. The tenderer should produce all original documents for verification, copies of which were submitted during the evaluation of part-I Technical bids, when so called for by the Official Committee or by the Tender Inviting Authority.

#### 6.4 **REJECTION**:

Any tenderer who fails to satisfy any of the conditions listed above shall be Summarily rejected.

#### 7.0 TENDER EVALUATION CRITERIA:

- 1. After the scheduled time, no documents will be received.
- 2. Tender documents should be submitted as per clause 2.4 failing which the tender will be rejected.

#### **Terms and Conditions:**

- All Pouch Packing Machines for Milk/Curd/Buttermilk etc., at Vellore Dairy should be operated and maintained by your Manpower and under your supervision.
- 2. The contractor should provide Two (2) Technicians/Shift (minimum ITI qualification awarded by Central/state Government approved institutions) with one unskilled manpower/shift for the operation and maintenance of pouch packing machine.
- 3. The contractor will be paid for every good pouches of Milk packed.
- **4.** a) The Contractor shall give the following minimum yield for different type of film and packing.

Type of packing	Film Quality	Yield Minimum Sachets/kg.
1000ml packing	60-65 micron	231 Sachets/kg of film
500ml packing	50-55 micron	422 Sachets /kg of film
250ml packing	50-55 micron	588 Sachets /kg of film
200ml Packing	50-55 micron	650 Sachets /kg of film

- b) If any changes made in the polythene film specifications the corresponding production yield intimated should be attained
- 5. At present the Union is packing around 2 Lakhs pouches (Milk / Curd) of different categories.
- **6.** For billing purpose only good pouches in cold store for distribution will be considered and counted as good pouches packed. Bill has to be raised for thirty days and payments of bill will be done within 15<sup>th</sup> of subsequent month after receipt of claim.
- Dairy will provide milk, water, pouch film, electricity, compressed air, and packing machines spares of drives, motors, gear boxes, PLC, HMI, SMPS and VFD. Rest of all materials will be of contractor's responsibility.
- **8.** The contractor has to operate the thermal print coding machines and for that Ribbon will be provided by Union.
- 9. In case when the plant and Cold storage leakage exceeds 1.5% the loss occurred due to wastage of film and milk will be deducted from the bill.
- 10. Manpower engaged by the tenderer will not be eligible for any benefit of VDCMPU Ltd., Vellore and they will never by said Employee of this Union. Any legal problem arise from manpower will be tenderer responsibility.

- 11. The responsibility of manpower provided by the tenderer with all respects i.e. Accident, Insurance, Labour acts'. P.F, E.S.I and Factory acts etc. In case any accident or any injury occurs to the employee deployed by the contractor, it will be the contractor's responsibility to pay the required compensation and comply with the Government authority etc. Case of failure by the contractor and any liabilities arises to the union the union will be reimbursed from the contractor all the amount and related expenses etc. otherwise union has right to recover all such amount from the contractors bill amount or from his deposit amount or from personal property etc. and it will be binding to his nominees and legal heir also.
- 12.The Contractor will have to provide E.P.F and ESI registration certificate and other legal documents which are required as otherwise the bill will not be released
- 13.The Employee Operators/Helpers, Workers etc., retained by the contractor neither are/will not the employee of the union in any circumstances nor union have any connection with staff, workers, operators, supervisor retained/ deployed by the party under the contract nor any of his (union) officials, supervisor dictate to the employee the manner of execution/ completion of the job, works assigned under the contract.
- 14. The Union will have the priority of contract with the party under the contract only and will give instruction to him and will have nothing to do concerned with the conditions of Employment of the worker operator supervisor helper etc. working for contractors party under the contract more over the union will not be entitled to any control supervision, manner of discharge, dismissal or retrenchment or reemployment of the worker engaged / deployed by the contractor.
- 15. The Court Deputy Registrar (Dairying), Vellore will be the Jurisdiction for any Dispute in the matter.
- 16.As per Labour law and as per the government order the wages to the contract employees will also applicable and the contractor has to abide and comply these conditions along with above stipulations.
