## PUBLIC AUCTION/ TENDER ADVERTISEMENT NOTICE

### R.C.No. 12984 /1431 /C4-1 Dated. 20.07.2022

Public Auction / Tender for the collection of tonsured hair of devotees of Arulmighu Mariamman Temple Samayapuram, and its subtemple Arulmighu Adhi Mariamman Temple, Inam Samayapuram, Trichirappalli District, Tamilnadu, for Fasli 1432 (06.08.2022 to 30.06.2023) was advertised in 13.07.2022 The Hindu, Page No: 11 to conduct on 29.07.2022 at 01.30 pm Mariamman Mandapam, First floor in Master plan complex Samayapuram.

At present this item has been decided to conduct through MSTC (E-Tender) on the same day i.e., on 29.07.2022 at 01.30 PM as per the same conditions. Therefore, the tender forms issued through <u>https://samayapurammariamman.hrce.tn.gov.in</u> and <u>http://www.tenders.tn.gov.in</u> to be conducted by the temple has been deleted now. Those interested to participate in the above E-Tender to be conducted by MSTC are requested to register theirselves at <u>https://www.mstcecommerce.com</u> and participate in E-Tender. As the e-tender is being conducted by MSTC, the following are the conditions of tender for hair collection license, venue of tender and other conditions related to tender form price, serial no. Conditions 3, 6, 7, 8, 9, 12, 43 highlighted in red are not applicable. Other conditions are said to be applicable to e-tender also.

Tiruchirappalli District, Samayapuram Arulmighu Mariamman Thirukoil and its sub temple Inam Samayapuram Arulmighu Adimariamman Thirukoil to enjoy the license to **collect and take the hair offered by the devotees for the** period commence from 06.08.2022 to 30.06.2023 (329 days) in fasli 1432 on Friday 29.07.2022 . Interested and eligible persons can participate in the public auction/tender opening as per the conditions by paying the deposit amount.

### Terms and Conditions

- 1. Only Hindus can participate in public auction/tender for hair collection license.
- 2. Those who owe dues to the temples in Tamil Nadu, minors, those who have committed bankruptcy, those who have been decreed against the temple, those who have acted against the welfare of the temple, litigants, those who have been convicted in the criminal court, temple employees, representatives of the above and their business partners are not allowed to participate in the auction / tender.
- 3. Tender form can be collected from 12.07.2022 to 28.07.2022 to 5.00 PM at the temple office during office hours by paying Rs.500/- in cash.

Or <u>https://samayapurammariamman.hrce.tn.gov.in</u> that of\_It can be downloaded from the temple website. The fee for the downloaded tender form is Rs. 500/- should be submitted along with the tender. The amount paid for the tender form is non-refundable.

4. Bidders are required to pay a deposit of Rs.50,00,000/- (Rupees Fifty Lakhs only) in the name of "Joint Commissioner / Executive Officer, Arulmighu Mariamman Temple, Samayapuram"payable at Indian Overseas Bank, Samayapuram Branch . shall be submitted as bank demand draft.

Deposits by cash or cheques are not accepted.

5. To participate in the tender, Bidders/Participants in Public Bid/Tender must submit certified copies of a) Aadhaar Card, b) Address Proof, c) Pan card for Income Tax,

d) Certificate for Small Entrepreneurs (MSME), u) Proof of Registration with Commercial Tax Department for the current period.

- At the venue of public auction/tender Participants in Public Auction / Tendershall submit, a) Proof of income tax payment to Government for last five consecutive years (FY 2017-2018 to end 2021 – 2022), b) Government documents of monthly GST filing for last one year (April 2021 to June 2022).
- Tenderers should keep only 1) filled in tender form, 2) original bank draft for deposit inside the sealed tender envelope and put in the tender box.
  The tender value should be written clearly in numbers and letters without any corrections.
- 8. Those participating in the public auction by paying the bid deposit, As per the details Rs. 50 lakh along with submission of original bank draft bearing serial no.4 Attested copies of seven documents mentioned in 5 and 6 should be submitted. After these documents are verified by the HR&CE officials, the name and address of the bid depositor will be entered in the bid register and then allowed to participate in the public auction.
- 9. Those who submitted tenders, a) already submitted along with the tender Rs. 50 lakhs copy of bank draft, b) serial no. 5 and 6 attested copies of the seven documents, c) Those who have downloaded the tender form from the website shall enclose a DD for Rs..Rs500/- Bank Draft should also be submitted. After these documents are verified by the Trustees, the tender depositor's name and address will be entered in the auction register and then they will be allowed to participate in the public auction/tender. Those who have paid the tender deposit can participate in the public auction and ask bidding guestions.
- 10. As per the above details, 1) Aadhaar card, 2) Address proof, 3) Pan card proof for income tax, 4) MSME certificate, 5) Current business registration proof, 6) Income tax payment proof for last five financial years. 7) payment of GST for the last one year. No person shall be allowed to participate in the public auction/tender, who does not submit copy of draft for deposit, proof of.
- 11. Bidders paying deposit for auction/tender shall be deemed to have paid the deposit and participated in the auction, only after having read and understood all the conditions and details of the licence.

- 12. Public Auction is obtained first and then the tender opening will be held. Immediately after the closing of the public auction, the tender envelopes received for this species will be opened and the highest bid amount asked in the auction and the highest tender value amount among the tenders received whichever is higher, the highest amount shall be recorded subject to the approval of the Commissioner.
- 13. The Bidder/Tenderer shall immediately pay the highest bid asking amount/tender value asked in the public auction without any balance in cash or draft. Cheque will not be accepted for any reason.
- 14. Only bank drafts drawn on the temple in the name of the highest bidder/ tenderer will be credited to the temple for the license fee.

Bank drafts for deposits of other persons paid in this public auction/tender cannot be credited to the highest bid/tender's asking amount for any reason.

- 15. Application for Commissioner's approval shall be made only after immediate payment of the highest bid/tender amount in full.
- 16. The Joint Commissioner/Executive Officer shall have full power to suspend, cancel, vary or reject the above auction/tender at any time including the status of the auction in the interest of the temple management without assigning any reason.
- 17. The Joint Commissioner/Executive Officer shall have full power to modify, cancel or add new tender conditions at any stage in the interest of administration.
- 18. If the temple management deems that the participants in the public bidding/tendering process do not bid/tender for a reasonable amount, the temple management reserves the right to suspend the public bidding/tendering process. No one has the right to object to this.
- 19. Public Auction/Tender is as per the rules of Tamil Nadu Government Hindu Religious & Charitable Endowments Act - 1959. The end of the public auction/tender in accordance with these rules is subject to the Veto power of the Commissioner, HR&CE.

The license will be confirmed and order will be issued from the temple only after acceptance and approval of the highest bid/tender amount by the Commissioner, HR&CE.

In case of auction/tender cancellation by exercise of Veto power without approval by the Commissioner, the deposit paid will be refunded later. No interest or loss amount will be given for this.

- 20. Those who are not confirmed public auction / tender, the original bank drafts for the deposit amount will be returned to the concerned after being recorded in the auction proceedings in the auction register and endorsed by the appropriate officers.
- 21. If the highest bidder fails to pay the license fee immediately after the close of public auction / tender, the deposit will be forfeited in full. Further, the tender and auction will be canceled and re-tender / re-auction will be held. Further all expenses including advertising expenses incurred in conducting re-auction/tender shall be borne by the person whose deposit has been forfeited. Also, if there is a shortfall in the bid amount in the re-tender auction, the previous bidder/tenderer has to make up for it. To the previous bidder/ tenderer if the re-bid/tender goes for additional amount. There is no right over this.
- 22. Once the bid/tender amount is approved by the Commissioner, the bidder/tender has to write a bond in government stamp for Rs.100/- to the temple, accepting the license conditions and accepting the license conditions.
- 23. Only after the surety bond has been written, the bid/tender has been accepted and confirmed, permission to enter the license will be issued.
- 24. Only the hair offered by the devotees is entitled to be collected. Otherwise, no share amount or any other amount will be given in any other species including Mudi ticket issued from the temple.
- 25. The licensees shall not act against the sanctity, purity and welfare of the temple and disturb the welfare of the servants.
- 26. In case of any disputes between the licensees and (employee of the licensee) the servants shall abide by the order / measures issued by the Joint Commissioner / Executive Officer in this regard.
- 27. To the licensee The temple administration will not be held responsible for any loss or damage due to Government Orders, divinity, natural calamity and any other reasons. Therefore, any fraction of license fee amount shall not be refunded under any circumstances.
- 28. By auctioning/tendering these licensed item/enjoying the licence, the licensee shall pay all other statutory taxes including Income Tax, GST (SGST, CGST) due to the government and all other statutory taxes and government charges at the tenderer's own risk within the due date to the government. The temple is not responsible for these amounts in any way.

- 29. In case of change in government tax rates, during the license period, shall be liable to pay the increased tax amount in full. The temple is not responsible for any such revised tax rates.
- 30. The tonsure shed shall be kept clean by the license with his staff at all times . The licensee has to pay the appropriate salary, EPF, ESI, employee contribution amounts as per relevant government regulations and also insurance at his own risk. The temple is not responsible for this in any way.
- 31. Tenderer cannot arbitrarily waive the license and transfer the license to anyone else for any reason.
- 32. After the expiry of the license period on 30.06.2023 in the afternoon, the entire rights shall automatically revert to the temple without any prior notice. After the expiry of the license period, the person who has bid/tendered has no right or follow-up regarding the license.
- 33. In case of violation of any of the above conditions, in case of disobeying the orders issued by the temple from time to time in the interest of the management and devotees, the Joint Commissioner/Executive Officer has full authority to cancel this license immediately, re-auction/ re-tender, confiscate the license fee and take other criminal actions as per law.
- 34. The tenderer has to collect the hairs in the 590 square feet space allotted from the temple. If more space is required then the space should be taken on rent by paying the reasonable rent per square feet determined by the temple. The collected hair should be removed from the place allotted by the temple within 3 days and the mudi mandapam should be kept clean without bad smell. Do not use other places of Mudi Mandapam for this purpose. Any place of the temple including Mudi Mandapam should not be used for any other work related to hair industry including processing.
- 35. The licensee must take out appropriate insurance and third party insurance at his own risk to get adequate relief from theft, fire and other natural disasters for the donated hair collected in the Tonsure shed. In case no such insurance is obtained, no compensation will be given by the temple. Also, they should purchase and maintain the necessary fire prevention devices at their own risk.
- 36. The temple administration has the right to give the licensee for collection of hair an alternative place in the interest of the temple instead of the allotted place for collection of hair. Neither the licensee nor anyone else has the right to object to this.

- 37. Due to the development of the temple, the temple has the authority to take back the building area even if it is currently allotted, if there is a need to carry out repairs, development works and conversion of the buildings. In this the licensee is not entitled to claim any compensation.
- 38. The licensee must not carry out any alterations or repairs in the allotted temple building area without the permission of the temple.
- 39. Separate electricity connection should be established at own cost for the place allotted by the temple for hair collection. The licensee shall pay the appropriate electricity charges in the name of the temple as per demand.
- 40. In case of any damage to tonsure shed building, temple staff, temple property and devotees due to the negligence/action of the licensee and employees of the licensee at the temple mudi hall, the licensee shall take care at his own cost and responsibility.
- 41. After the expiry of the license period, obtaining clearance certificate a) No tax due to the government including income tax, GST, etc. is due for the hair collection license from the concerned departments and submitting it to the temple's deposit amount of Rs. 50 lakh out of Rs. 40 lakh only will be refunded. b) After the completion of the Audit, for the license period and the receipt of the Audit report, the remaining deposit amount of Rs.10,00,000/- (Rupees Ten Lakhs) paid for the auction/tender will be returned after consideration of the Audit report.
- 42. The Collection of human hair work in Temple's Tonsure shed should be carried out in full compliance with the orders announced by the government from time to time regarding the prevention of corona virus.

43. In the current situation (Covid-19) due to Corona virus prevention measures, those participating in the auction/tender opening are requested to undergo body temperature test, wear face mask and participate in the auction/tender opening strictly following the norms announced by the government.
