#### **ELIGIBILITY CRITERIA**

#### 1) Pre-qualification criteria

#### Authorization:

Only Original Equipment Manufacturers (OEM) or their representatives / authorized dealers are eligible to apply. [They need to produce authorization letter in the prescribed format. (**Schedule IV**) ]

- i) In this tender, either the Indian agent on behalf of the Principal / Original Equipment Manufacturer (OEM) or Principal / OEM itself can bid but, both cannot bid simultaneously for the same item.
- ii) If an Indian agent submits bid on behalf of the Principal / Original Equipment Manufacturer (OEM), the same agent shall not submit a bid on behalf of another Principal / OEM in this tender.
- iii) The tenderer should not have been black listed by any State / Central Government / Public Sector Undertakings during the last 5 years. (Undertaking to be submitted)

#### 2) Undertaking:

#### 6) Installation & Warranty Declaration:

Suppliers must give the comprehensive onsite warranty as required from the date of successful delivery of Instruments / Equipments / Mobile Forensic Vehiclesagainst any manufacturing defects. The model, number of Instruments / Equipments / Vehicle and all spares parts / accessories numbers should be entered as in the line of purchase order and suppliers are required to submit the warranty certificate (as per <a href="Schedule-XII">Schedule-XII</a>). If any item covered under warranty fails, the same shall be replaced free of cost including all the applicable charges (shipping cost both ways). But in the event of any breach of agreement at any time on the part of the contractor, the contract shall be terminated by the Tender Accepting Authority on behalf of the Governor of Tamil Nadu upon giving fifteen days' notice to the contractor.
- The item to be supplied under this contract are to be of the quality of sort specified and in every respect equal and answerable to the technical specifications of instruments submitted during evaluation, (as per the technical Compliance format enclosed along with the technical specification) and such as the Government or any other duly authorized authority shall approve.
- The item are to be delivered free of charge at the contractor's risk in such quantities or number at such times and in such manner as the Director, Forensic Sciences Department Chennai or anyone duly authorized by him/her shall from time to time order. If freight charges are claimed they will not be admitted.
- Rejected item shall be removed by and at the expense of the contractor within seven days after receipt of such notice. If not so removed, the Director, Forensic Sciences Department, Chennai, may cause the item to be removed and charge the contractor with all expenses incurred in such removal
- 5. In case of failure by the contractor to deliver item demanded from him within the period specified for delivery or in case of item delivered by him not being of the stipulated quality, sort, weight or measure or in case of articles being delivered without a correct invoice in triplicate, the Director, Forensic Sciences Department, Chennai or anyone duly authorized by him shall have power to reject any such item and to purchase from others instead of any item so rejected or not delivered. Unless the contractor shall himself forthwith supply that shall be sufficient and satisfactory, any excess of cost so incurred by the Govt., over the contract price together with all charges and expenses attending the purchase shall be recoverable by the Govt., from the contactor.
- 6. In case of failure to complete the supplies within the date of delivery specified in terms of the contract placed on the contractor in preference to the lowest acceptable offer shall be recoverable by the Govt., from the contractor.
- 7. The contract or any part, share or interest in it shall not be transferred or assigned by the contractor directly or indirectly to any person or persons whomsoever without the written consent of the Director, Forensic Sciences Department, Chennai.
- 8. The Contractor shall make his own arrangements for obtaining import licenses in respect of item tendered for supply under this contract from the authorities concerned and in no case his applications will be forwarded in this regard.
- 9. The Govt., hereby agree that during the term fixed by this contract, and except as herein provided Govt., shall not purchase from any persons other than the contractor or from any company or corporation all or any quantities of the goods or materials agreed to be supplied by the contractor.

- 10. # GENERAL TERMS AND CONDITIONS FOR THE TENDER FOR THE SUPPLY OF INSTRUMENTS / EQUIPMENTS / MOBILE FORENSIC VEHICLES TO FORENSIC SCIENCES DEPARTMENT

#### **Tender form**

- 1. The tender schedule is not transferable and it should be used only by the tenderer to whom it is officially issued by the Forensic Sciences Department.
- 2.Only the tender document supplied by this office/downloaded from the designated website should be used and it should be resubmitted in full shapewithoutdetaching/modifying any page from it. Tenders in any forms other than the forms and schedules issued by the Department to the Tenderer will not be considered and will be rejected as non-responsive.
- 3. Incomplete tender documents will be rejected.
- 4. Each page of the tender document, including technical specifications, should be duly signed.
- 5. When the tender is made by an individual, it shall be signed with his name and address and in case of a partnership firm, it shall be signed by one of the partners empowered to submit tenderson behalf of the partnership as contemplated. If it is made by a Company or Corporation it shall be signed by an officer duly authorized for the purpose. In all cases, the status of the tenderer, whether a proprietorship, partnership, company or corporation should be furnished in the covering letter with full address of the tenderer's name, names of partners, directors etc. The tenderer should also furnish such particulars / evidence as may be required by the competent authority in this department before execution of the agreement.
- 6. If any covering letter accompanying the tender document is in the tenderer's letter head form, allterms and conditions printed there in should be scored out and duly authenticated. It should be distinctly understood that such printed terms and conditions in the letter head will not have any binding on this department and those terms and conditions quoted in the tender document only will be considered.

- 17. Prices quoted should include the cost of all accessories <u>essential to make the Instruments / Equipments / Vehicle /</u> as per Technical specification. The price of only one model of the Instruments / Equipments / vehicle should be mentioned.
- 18. The country of manufacture of the vehicle and of the materials and parts used in the manufacture or assembly of the item should be clearly noted in the tender.
- 19. The rates should be kept by the tenderer for 1 year from the date of opening of the tenders for acceptance.
- 20. No charges other than those mentioned in the supply order will be paid under any circumstances.

#### **Demonstration of equipment and Evaluation**

- 21. The tenderer should produce the Instruments / Equipments / Mobile Forensic Vehicle which he has quoted in the tender document for demo before the technical evaluation committee as and when called for. If it is not feasible for the tenderer to produce the Instruments / Equipments / Mobile Forensic Vehicle for demo before the technical evaluation committee, he may arrange for such demo, at his own risk, in the organisaton / laboratory / agency where such Instruments / Equipments / Mobile Forensic Vehicle which is quoted in the tender document, has been supplied. Seeking time for demonstration by the tenderers on his own accord will not be entertained.
- 22. The tender will be rejected if the is not produced for demo and the EMD is liable to be forfeited in the event of such failure.
- 23. EachInstruments / Equipments / vehicle produced for demonstration must have a label attached to it, showing clearly the name of the tenderer and the country of manufacture and that of the origin of material used in the manufacture.
- 24. Evaluation will be based on whether the Instruments / Equipments / vehicle meets the vital specifications and upon the quality and durability of the product and terms and conditions regarding warranty, training and servicing capability.

#### 25. **DEMO PROCEDURE:**

If the Instruments / Equipments / Mobile Forensic Vehicle supplied for evaluation meets the tender specifications it would be treated that the Instruments / Equipments / Mobile Forensic Vehicle had passed the "specifications test". If the specifications are below the tender specifications, then the Instruments / Equipments / Mobile Forensic Vehicle would be treated as "failed" in the "specifications test". The tenderers should take utmost care to bring in the Instruments / Equipments / Mobile Forensic Vehicle which should be equal to or better than the specifications given in the tender documents. Department reserves the right to reject theInstruments / Equipments / Vehicle, if it is found that it does not meet the specifications. In such cases, the tenderers would be treated as "failed" in this test. However, Department reserves its right to offer one last opportunity to the tenderer to produce another for evaluation, say within a short period of 2-3 days. Such a sample would be evaluated solely at the discretion of Department and the Department would be pleased to provide such an opportunity if public interest (for healthy competition) demands such a step. In the normal course, such an additional opportunity would not be given to the tenderers.

#### Warranty

- 26. The specified Comprehensive onsite extended warranty for the maintenance of Instruments / Equipments / Mobile Forensic Vehicle supplied by the tenderer shall be provided.
- 27. The warranty shall cover defects in Instruments / Equipments / Mobile Forensic Vehicle or poor workmanship with company / factory trained personnel and service during the period of warranty notwithstanding the fact that the Instruments / Equipments / Mobile Forensic Vehicle were inspected and approved by inspecting officers.

#### Acceptance of tender

- 28. Notification of acceptance of tender by the department shall be deemed to result in and constitute a valid and considered contract binding on the tenderer. If the tenderer withdraws his / her tender after acceptance by the department, the EMD shall be forfeited.
- 29. A tender may be accepted for one or more or the whole of the Instruments / Equipments / Mobile Forensic Vehicle and their accessories / peripherals, as the case may be.

#### **Release of Purchase Order**

30. The contractor should examine carefully the purchase order immediately on receipt and bring to the notice of the indenting officer within five days of receipt of purchase order any discrepancy with regard to the quantity ordered, specifications, packing, etc., for prompt rectification. The letter should be sent by registered post with Acknowledgement due. Meanwhile, supply of the Instruments / Equipments / Mobile Forensic Vehicle which are cleared in all respects for dispatch and acceptance by the consignees shall be arranged by the date mutually agreed upon and should not be held up for any reason whatsoever.

#### **Agreement**

- 31. The successful tenderer should execute an agreement in non-judicial stamp paper, having a face value of Rs.20/- within 15 days from the date of notification of acceptance by the department for the due fulfillment of the contract. If the value of the tender exceeds Rs.10,00,000/- (Rupees Ten Lakhs) the said agreement should be executed in non-judicial stamp paper, having a face value of Rs.100/- within the aforesaid stipulated period. If failed, the provisional order will be cancelled and the EMD amount paid will be forfeited.
- 32. Successful tenderers will be required to execute an agreement in the form, which is available at the office of the Director, Forensic Sciences Department, Chennai. The stamp duty on the Agreement shall be borne by the successful tenderer. On their executing the agreement, the EMD will be returned to them. In case of firms outside Tamil Nadu State, the EMD received will be returned to them by Demand Draft / Bankers' cheque.

#### **Security Deposit**

33. Security Deposit /Bank Guarantee given by any Nationalized Bank equivalent to five (5%) percent of the total value of the supplies contracted for will have to be furnished by the successful tenderer. This is liable to be forfeited either in full or in part for any breach of conditions of contract or default on the part of the contractor. Security deposit paid by the successful tenderer will not bear any interest.

Security deposit of five (5%) percent will be returned after getting a certificate from the user unit to the effect that the items purchased are up to their satisfaction.

34. The EMD will be forfeited if the successful tenderer fails to remit the security deposit and execute the agreement within the period specified. The security deposit will be refunded only upon satisfactory fulfillment of the contract after completion of supply of the entire Instruments / Equipments / Mobile Forensic Vehicle ordered and expiry of the warranty period duly adjusting the amount due to the Department, if any.

#### 35. Performance Guarantee Bond

- a. Performance Guarantee Bond is mandatory.
- b. Successful supplier / firm should submit performance guarantee as prescribed and to be received in the office of Deputy Registrar, Administration and Materials Management Division before the date of commencement of supply or 30 days from the date of acceptance of the purchase order, whichever is earlier. The performance guarantee bond to be furnished in the form of Bank Guarantee as per given proforma of the tender documents, for an amount covering 3% of the value of quantity of material on landed cost basis.

- c. The Performance Guarantee should be established in favour of "The Director, Forensic Sciences Department, 30A, KamarajarSalai, Chennai-600 004" through any Nationalized Bank / Schedule Bank.
- d. Validity of the performance guarantee bond shall be for a period of entire warranty period from the date of installation and commissioning.
- 36. On successful completion of installation and supply to the satisfaction of the Forensic Sciences department and on receipt of the invoice bill in triplicate, 100% payment will be settled based on budgetary provision.
- 37. The Director, Forensic Sciences Department, Chennai, acting on behalf of the Governor of Tamil Nadu or any other authority empowered in this matter shall have the right of rejecting any tender without assigning any reason for doing so.
- 38. The Director, Forensic Sciences Department, Chennai or any other authority empowered shall have the right of requiring a successful tenderer to supply more than the required number of quantity of the Mobile Forensic Vehicle mentioned in the schedule than the number or quantity mentioned therein.

# 39. <u>Terms for rejection of Instruments / Equipments / Mobile Forensic Vehicles.</u>

- f the country of manufacture and the origin of material used in manufacture of Instruments / Equipments / Vehicles is not mentioned in the tender.
- b) If the tender is not in the form supplied by this office/downloaded from the Tamil Nadu Government website (www.tender.tn.gov.in)
- c) If Instruments / Equipments / Mobile Forensic Vehicle quoted are not submitted as and when required as per condition vide SI. No. 21 and 22 of Page 23 for technical evaluation test, the EMD amount paid by the Tenderer will be forfeited.
- d) If the tender is not accompanied by the receipt of the Earnest Money Deposit.
- e) If the tenderer imposes any restriction on other conditions in his tender.
- f) If the tenderer enters one rate in figures and another in words and declines to abide by the lower of the two.
- g) If the tenderer alters the period of supply or expunges any clause in the form of tender
- h) If the tender is presented without signature.

#### **Reservation of rights**

- 40. The authority competent reserves the rights:
  - a) To award contract to one or more tenderers in respect of each item covered by the tender.
  - b) To reject any or all the tenders without assigning any reasons there-for.
  - c) **To relax or waive or modify** at his discretion any of the condition/specification in the interest of the department
  - d) The decision of the tender accepting authority of this department in this regard shall be final, conclusive and binding on the supplier.

#### **Delivery**

- 41. The rates accepted will be for delivery at such destinations as indicated in the tender document or in subsequent purchase order. The delivery and installation should be made within the stipulated period prescribed in the purchase order. Otherwise penalty clause will be levied.
- 42. The supplier shall reckon the delivery period from the date of receipt of the purchase order. The date of delivery as per postal acknowledgement due in the case of purchase order sent by post or the date of delivery if delivered in person or through special messenger, shall be deemed to be the date of receipt of the purchase order.
- 43. Delivery period is inclusive of pre-delivery inspection. The date of delivery of Vehicles in good condition to the consignees shall be the date of supply. The rate indicated in the purchase order should be maintained. The materials should be delivered to the consignees as per the purchase order placed.
- 44. Acceptance of materials by the consignee:- If on examination of the Instruments / Equipments / Vehicles, any portion of the supplied Instruments / Equipments / Vehiclesare found to be damaged or substandard or not fully in accordance with the relevant specifications, the whole supply shall be rejected irrespective of the fact that this material was cleared under predelivery inspection. The Instruments / Equipments / Vehicles should be strictly conform to the specifications given in the tender conditions. In case of doubt whether the materials conform to the specifications or not, the decision of the consignee shall be final. The consignee has the right to reject the Instruments / Equipments / Mobile Forensic Vehicle found not conforming to the specifications and they should be replaced within seven days at the cost of the supplier.

## **Penalty**

- 45. Where the supply is not completed within the delivery schedule, without prejudice to the right of the department to cancel undelivered portion of the purchase order, extension of time may, if so required by the contractor may be granted at the discretion of this department. Such extension of time will entail recovery of penalty from the contractor at one percent per week, on the value of the undelivered quantities subject to a maximum of five percent of the value of the undelivered quantity.
- 46. The Tender Accepting Authority will have the right to cancel the purchase order and to recover from the contractor liquidated damages at 2% of the value of the undelivered quantity or the extra financial commitment to this department on the purchase of the balance quantity, whichever is higher besides forfeiting the security deposit/bank guarantee. The Three (3%) percent of the payment amount/ bank guarantee will be retained during the warranty period as performance guarantee and will be paid after successful completion of the warranty.
- 47. The Instruments / Equipments /fabricated vehicle should be delivered within the prescribed delivery schedule mentioned in the purchase order. If not, thereafter, Forensic Sciences Department holds the option to complete the fabrication work of the vehicle through alternate sources at the risk and cost of the defaulting contractor / supplier.

#### Certificates and details to be furnished

- 48. Latest income tax clearance certificate and latest appropriate tax verification certificate should also be appended with the tender document.
- 49. The following certificates should also be furnished: (a) Valid NSIC Registration Certificate, if registered under NSIC, (b) Valid SSI Registration Certificate, if registered under SSI, (c) An existence certificate and capacity certificate for the particular item of Tender issued by the authorized SSI / NSIC and, (d) Forensic validation certificate, wherever necessary, should be produced.
- 50. The Tenderer should furnish details of orders executed for Government departments / autonomous body, etc., and details of orders on hand or pending execution. Certificates in proof of these should also be furnished.
- The tenderer shall furnish the location and full address of the factory and the details and capacity of the plant.
