We, Tamil nadu Newsprint and Papers Limited (TNPL), would like to Enlist Vendors to procure imported Waste Paper.

Sorted White Ledger(SWL) Gr:40- as specified by ISRI

The Enlistment Application Form is enclosed. Please fill up the details called for in the Enlistment form along with documentary evidences wherever required and send the same to us on or before the due date i.e. **before 3 PM on 05.08.2022.**

In this connection please find the below qualifying criteria -I for vendor enlistment.

Qualification Criteria – I

1. The bidder should be a supplier of any grade of imported waste paper and should have successfully completed supplies for at least 15,000 MT of imported waste paper to any Indian or international consumer during the past two years period prior to **June- 2022.**
2. A certificate of performance obtained from the Customer is to be produced.
3. In case of submission of bid by Indian agent, authorization from the Principals to submit bid on their behalf and to deal with TNPL should be submitted. The Indian agents shall not change their Principals once the bid is made.
4. A certificate from bank regarding financial stability of the Indian agent should be furnished.
5. Acceptance for submission of Earnest Money Deposit (EMD) of Rs.1,00,000/- against individual tenders for procurement of Waste Papers.
6. Submission of Enlistment fee of Rs.590/-by DD in favor of Tamil nadu Newsprint and Paper Limited in case the enlistment form has been downloaded from TNPL website.
7. The supplier should strictly follow material specification & packing details of the TNPL
8. Moisture, Mixup etc. complaints are to be addressed within 5-7 days.
9. For any shortage complaints, weight recorded at TNPL weigh bridge is final and binding.

However, in case of new suppliers who are not able to meet the above qualification criteria, they may get enlisted by meeting the following Qualification criteria – II as mentioned below

Qualification Criteria – II : (Vendors who get qualified in SOP – Trial order will get qualified for supplying other grades of Waste Paper also)

1. In case of submission of bid by Indian agent, authorization from the principals on their behalf and to deal with TNPL should be submitted. The Indian agent shall not change their principals once the bid is made.
2. A certificate from bank regarding financial stability of Indian agent should be furnished.
3. Acceptance for submission of Earnest Money Deposit of Rs.50,000/- at the time of releasing trial order and for submission of another Rs.50,000/- at the time of participating in our enquiry after successful completion of trial order.
4. Submission of enlistment fee of Rs 590/- by demand draft in favour of Tamil nadu newsprint and papers limited payable at karur / kagithapuram in case the enlistment form is downloaded from TNPL website.
5. A Trial purchase order will be placed at the existing procurement price of Imported waste paper on acceptance of sample (2Kg).
6. Acceptance to supply 150MT on a trial basis in single shipment within 3 months from purchase order date.
7. Acceptance for the following payment terms:
" 100% payment will be made against telegraphic transfer after 45days from the date of receipt of material subject to acceptance of materials by TNPL"
8. The supplier should strictly follow material specification & packing details of the TNPL
9. Moisture, Mixup etc. complaints are to be addressed within 5-7 days.
10. For any shortage complaints, weight recorded at TNPL weigh bridge is final and binding.

The Enlistment application Submitted by the Vendors would be scrutinized by TNPL with reference to the above qualifying norms and those meeting the qualifying norms will be enlisted for supply of imported waste paper.

Periodical tenders will be extended to the enlisted parties for the procurement of imported waste paper. TNPL would follow e - tender cum Reverse auction method to finalize the procurement.

The due date for submission of Enlistment Application Form is **05.08.2022 at 3.00PM.**

TNPL reserve the right to reject any enlistment application at it's own discretion without assigning any reason whatsoever and **TNPL is not responsible for postal or any other delay in submission of enlistment application by the vendors.**

Vendors who were already enlisted with TNPL for supply of Imported Waste Paper need not apply again.
