

- 7.4 All the envelopes, viz. **UNPRICED** Techno-Commercial (UTC) Bid & **Price Bid** and the **outer envelope**:

 - shall bear on the top left hand corner, TNPL's Bid Number as also bid opening date and time.
 - shall bear on the bottom left corner the name and address including phone/fax numbers and email ID of Bidder.
- The Unpriced Techno Commercial (UTC) Bid must be accompanied by a Bid Security of **Rs.50,000/-** (Indian Rupees Fifty Thousand only) or equivalent foreign currency, in one of the following forms:
 - (a) An unconditional bank guarantee issued by a bank located in India, acceptable to TNPL in the form provided in Part 2 of the Bid Document.
 - (b) A Demand Draft in favour of Tamil Nadu Newsprint and Papers Limited.
