2. Tenderer should post the Quotation in tender box placed in the temple office on or before **01.00 P.M. on 09.08.2022**

5. The conditions stipulated in the form should be strictly adhered to and violation of any of the conditions will entail termination of the contract without prejudice to be right of the authority and to recover any consequential loss from the successful tenderer.
13. Temple shall not pay increase in duties, taxes and surcharges on account of any revision by the Government at the time of supply and installation.
14. **The tenderer should quote as per the tender specifications Kitchenware, Furniture and generator for commercial purpose. So the Quality, Size, Specification, Usage, Durability and Standard are to be in means of Commercial purpose only (Community Hall)**
15. Faxed Bids are liable to be rejected.
16. The EMD of the unsuccessful tenders will be refunded immediately after the tenders are disposed of by the competent authority.
17. If the tenderer failed to act up to the tender or backs out when his tender accepted, Security deposit will also be forfeited to department.
18. The material should be supplied strictly in accordance with the specifications given in the schedule and should fulfill the successful tests carried out by the Competent Authority . The supply and installation should be made as per the delivery schedule to be sent by the Executive Officer along with the exact location of the work. The guarantee period shall take effect from the date of trial run. Successful tenderer shall be liable to change any defective part during the warranty period. In either case the damaged or defective items will have to be taken back at supplier's cost and risk.
19. The Commissioning and installation should be getting completed within the stipulated period mentioned in the supply order. If the supply is not made within the period, the supply order will be cancelled and the EMD & Security deposit will be forfeited.
20. The materials are to be guaranteed for the warranty period mentioned as per the given specifications from the date of installation and commissioning against manufacturing defect and bad workmanship. The period of warranty and the Annual Maintenance Contract (AMC) are as per the given specifications and the specified period shall commence from the date of installation.
21. **The materials quoted shall confirm to ISI standard. The make of the materials shall be mentioned in the tender.**
22. Any dispute arising out of this contract shall be settled only at the court having jurisdiction of Villupuram.
23. The authority competent to accept the Quotation reserves the right to reject or accept any quotation without assigning any reasons thereof.
24. Regarding the acceptance of supply with reference to the specification and quality of materials supplied, the decision of Executive Officer shall be final.
25. Loss or Damage: External damages or shortages that are prima facie the results of rough handling in transit or due to defective packing will be intimated within a fortnight from the date of receipt of the material, Internal defects, damages of any internal parts that cannot ordinary be exhibited on superficial inspection though due to bad handling in transit or defective packing will be intimated within two months from the date of receipt of the stores. In either case the damaged or defective stores will have to be taken back at supplier's cost and risk.

26. Guarantee: The Supplier shall undertake to repair free of charge or replace any defective part of the equipment supplied due to defective or faulty design or bad workmanship during a period of three years from the date of commissioning of the equipment.
27. If the contractor fails in due performance of this contract, within the time fixed by the contractor the extension thereof, the contractor is liable at discretion of the purchaser to a penalty of 4% per month of the contract value of such portion only of materials as cannot, in consequence of the delay, be used during each month between the appointed or extended time as the case may be and the actual time of acceptance, and such penalty shall be in full satisfaction of the contractor's liability for the delay but shall not in any case exceed 25 % of the contract value of such portion of the materials."
28. Tenderer have to quote all the given items in the schedule, if any of the items is not quoted their tender will be invalid.
