## **12. SPECIFICATIONS**

The Electronic Weighing Platform Scales strictly confirming to specifications of ISI marking. BIS IS 9281 Part III 1981 and other supplementary specification as noted in Annexure – C. The Regional Committee will check the scales. If not confirmed to specification, it will be liable for rejection. First stamping should be done by the Department of Tamil Nadu Government only stamping done at other state will not be accepted. This stamping should be arranged by the supplier at their cost & risk.

## **13. PRICE OFFER :**

- 13(a) Rates for supply of New 200 Kgs Electronic Weighing Platform Scales should be quoted as per Part II Annexure- containing the Schedule.
- 13(b) The Price offer for supply of New 200 Kgs Electronic Weighing Platform Scales should be kept in the Part II.

## **14. PRICE EVALUATION**

- 1. The evaluation of L1 will be done as per the rule 29(2) (d) of the Tamil Nadu Transparency in Tenders Act 1998 and Rules 2000.
- 2. It is not binding on the part of the Managing Director, TNCSC to accept the lowest or any other tender and he reserves the right to reject or accept all or any other tender fully or partly without assigning any reasons therefore, the Managing Director reserves the right to accept one or more tenders for supply.

### **15. WARRANTY PERIOD:**

- a) A minimum One year warranty should be given for the scales supplied by the tenderer. During the warranty period of one year, the approved tenderer must ensure that regular services are attended and break down calls are attended immediately at free of cost.
- b) If any parts including load cell, PCB and Battery failed within the warranty period, it should be replaced by the Tenderer on free of cost.
- c) During the warranty period of one year, First Stamping is borne by the Supplier for Tamil Nadu Government, Stamping only. (Government fees) and Second year will be borne by TNCSC.

### **16. DURATION OF SUPPLY DELIVERY AND PENALTY:**

- 1) The supply of 500 Nos. of 200 Kgs. capacity Electronic Weighing Platform Scales should be as per specification specified in Annexure – C and to complete within 60 days from the date of issue of order. If not supplied within the stipulated time, it will attract penalty at the rate of 0.5% per week up to 5% on the value of the items belated supply. Delay beyond that period will result in cancellation of order. This will be at the discretion of the TNCSC.
- 2) At the time of delivery by the tenderer the Electronic Weighing Platform Scales will be subjected to 100% check at the unloading point. The checking will be done by the committee formed by the TNCSC. In the event of Electronic Weighing Platform Scales not conforming to specification the rejection of the scale by committee at unloading point will be final and should not be disputed by the supplier. At the time of inspection, the authorised representative of the company should be present.

### **17. PAYMENT:**

- a) Payment shall ordinarily be effected only on completion of delivery against the orders placed.
- b) The Payment will be made by the concerned Regional Manager / Senior Regional Manager after deducting the value towards Penalty charges for belated supply if any, on presentation of the following documents by the supplier at concerned **Regional Office of TNCSC**.
  - i) Seller's bill in duplicate on the basis of the confirmed rates.
  - ii) Acknowledgements/Stock Certificates issued by the incharge of the Godowns.
  - iii) Committee report issued by TNCSC officials

- c) The payment will be made by RTGS in favour of the Tenderer by the **Regional Heads concerned.**
- d) Only 90% value of the bill for the supply made will be paid to the supplier. 10% of the bill will be paid after the successful completion of the warranty period of one year.

## **18. OTHER CONDITIONS**

- 1) The Managing Director reserves the right to reject any tender without assigning any reasons there for and it shall not be questioned on any ground, whatsoever.
- 2) After supplying scales, the company has to make necessary arrangements to give training to the employees in each Godown regarding the operation of the scales.
- 3) At the time of supply, all the scales should be accompanied with the User Manual in Tamil and it should contain details of frequently asked question (FAQ) and the replies therefore.
- 4) At the time of delivery, instructions for operation the scales Do's and Don'ts (i.e.,) how to operate the scales correctly and things could not be done at the time of operating scales should also be given in Tamil.
- 5) TNCSC reserves the right to vary the quantity ordered to be purchased to the extend of 25% either way of the requirement of the commodities indicated in the tender documents. The tenderer cannot claim it as a matter of contractual obligation to vary the quantity either way.
- 6) In the event of the failure of the successful tenderer to deliver the Scales within the stipulated time it shall be open to the Managing Director, Tamil Nadu Civil Supplies Corporation to purchase the Electronic Weighing Platform Scales from any other source at the available rates at the risk, and responsibility of the successful tenderer and to claim any loss suffered by TNCSC in the transaction from the tenderer besides forfeiture of Earnest Money Deposit and Security Deposit as well.
- 7) **Managing Director can recover any dues from the tenderer which is found on a later date during the Audit/Excess payment after final settlement is made to them. Accordingly the tenderer is liable to pay such dues to the Corporation.**

- 8) If any supplies made are found to be damaged or defective or not conforming to the prescribed size and specification, the same will be rejected. The rejected Electronic Weighing Platform Scales should be taken back by the tenderer at their risk and cost and the replacement shall be effected at the cost of supplier within 15 days of rejection.
- 9) The TNCSC also reserves the right to relax or waive any of the tender condition / conditions.

**19. AGREEMENT:**

The successful Tenderer should execute an agreement on a non-judicial stamp paper of value, as prescribed in law on the date of remittance of Security deposit. In the event of failure to execute the agreement, within the time prescribed, the EMD / SD amount remitted by the Tenderer will be forfeited. and also Blacklisted for 3 consecutive years.

**20. TERMINATION OF THE CONTRACT:**

In the event of failure to supply the ordered quantity of New 200 Kgs. capacity Electronic Weighing Platform Scales by the successful tenderer within the stipulated time fixed, TNCSC reserves the right to cancel the orders (or) to take action to terminate the contract, forfeit the Security deposit and to purchase the 200 Kgs. capacity Electronic Weighing Platform Scales through tender or through any other mode of alternative purchase at the risk and cost of the defaulted supplier and such a supplier is liable and responsible to make good the financial loss sustained by the Corporation.

**21. ARBITRATION :**

- a) In case of any dispute in the agreement, including interpretation if any on the clauses of the agreement to be executed, the matter shall be referred by the corporation / Tenderer to an Arbitrator who shall be selected by the party, from the panel of Arbitrators, approved by the Board of Directors of TNCSC and communicate the same within 15 days, from the date of receipt of the letter from the corporation along with the panel.
- b) If there is no reply from the Tenderer within 15 days, corporation shall choose any one of the Arbitrators from the panel of Arbitrators referred to above. The

remuneration for the Arbitrator and other expenses shall be shared equally by the TNCSC and the party.

- c) The venue of the Arbitration shall be at the Head office of the TNCSC Chennai. The decision of the Arbitrator shall be final and binding on both the parties to the Arbitration.
- d) The Arbitrator may with the mutual consent of the parties, extend the time for making the award. The award to be passed by the Arbitrator is enforceable.
