- c. Concrete mix for construction of wall, floor and roof should confirm to M20 minimum.
- d. Reinforcement steel bar 12mm
- e. Reinforcement grid mesh in mm- 150 x 150 CTC e. Tang bars- not mandatory
- 11. The Technical Bids will be opened on 24.05.2022 at 4.00 PM at Regional office, Balasore in presence of the bidders or their authorized representatives. All the bidders are advised in their own interest to be present on the date at the specified time.
