ANNEXURE-2

TERMS AND CONDITIONS FOR TENDER DOCUMENTS

1. The Premises Owner should have a clear Title over the property/premise. The building should have necessary permission/authorized construction and should have necessary permission from competent authority to use it for commercial purpose. All statutory dues should have paid/cleared till date.
2. The premises preferably on the main road with clear visibility and situated on the Ground Floor.
3. The premises should have proper ventilation and have sufficient parking area.
4. The premises area should not have any water logging problem.
5. The premises should have separate electricity connection and water connection with separate meters.
6. The total Carpet area of the building be around 1700 sq.ft. with a variation of up to [+/-10%]
7. The total area is subject to joint measurement by the owner and empaneled architect of the Bank and structural fitness is subjected to inspection by the architect and security officer of the Bank
8. The lease period will be for 15 years [min 10 years]. Lease deed should be registered with SRO and the cost of registration will be shared on 50:50 basis
9. The premises will be used for Banking transaction and for ATM/any other purpose as deemed fit for the Bank.
10. The owner should provide separate entry to the Bank and ATM from outside. The owner should provide Ramp facility to the Bank as well as ATM for the benefit of physically disabled person.

 3. Concrete mix for construction of strong room should confirm to M20 specifications
 4. Reinforcement steel bar of 12 mm and reinforcement grid mesh in mm 150x150x150 CTC
 5. Strong room construction will be under the supervision of Bank's architect/Security officer
