- 7. Tender shall remain valid for acceptance for a period of 90 days from the notified last date of tender submission.
- 8. The Bank reserves the right to reject any or all tender received without assignment of any reasons thereof.
- 9. The tender rate against each item of work / price indicated in the schedule of quantities and rates / price should be indicated both in words and figures. In case of any discrepancy, the rates indicated in words would prevail.
- 10. The rates quoted against each item of work / price should be for the complete finished item of work and include all labor, material, overhead, duties, etc but excluding GST which should be quoted separately. The Bank shall reimburse any statutory change in the tax structure after opening of the tender actual.
- 11. Each tender shall be accompanied by Earnest Money of Rs.4500.00 (Rupees Four Thousand Five Hundred only) in the form of Pay Order / Demand Draft in favor of Union Bank of India, payable at Bhubaneswar. Tenders without Earnest Money shall be summarily rejected.

- 15. The work is to be carried out in ATM Premises & the time period provided for completion of work is inclusive of load shedding hours & aforesaid constraints. The contractor should make his own alternative arrangement at his own cost to compensate with load shedding hours & no additional remuneration shall be paid for such arrangements nor will any additional time be granted on this account.
- 16. The tenderors shall be presumed to have carefully examined the drawings, conditions and specifications of the work and have fully acquainted themselves with all details of the site and with all the necessary information and data pertaining to the work prior to tendering for the work.



SCHEDULE OF RATES.

- 1. The Schedule of Rates shall be read with all the other sections of this tender.
- 2. The tenderer shall be deemed to have studied the drawings, specifications and details of work to be done within the time schedule attached and to have acquainted himself of the conditions prevailing at site.
- 3. The tenderer shall be deemed to have visited the work place and acquainted themselves / himself from all the favourable / adversible conditions prevailing and have quoted the rates taking into account of all the eventualities.
- 4. The quantities shown against the various items are only approximate and may vary to any extent individually. No extra shall be entertained whatsoever.
- 5. The Owner reserves the right to interpolate the rates for such items of work falling between similar items of lower and higher magnitude.
- 6. All works, item-wise, shall be measured upon completion and paid for at the accepted rates.
- 7. The Owner reserves the right to cancel the order for any item or group of work, or split the work between two or more contractors if necessary.
- 8. All the items of work mentioned in the Schedule of Rates and covered by the contract shall be carried out as per drawings, specifications and directions of Architect & the Engineer-in-Charge of owner and shall include all labor material, transportation, lift floor, handling, duties, octroi, wastage, tools and plants, tackles, testing if any with Contractor's testing appliances etc., required to complete the job in all respects.
- 9. Unless otherwise specifically provided in the Schedule of Rates, rates quoted for various items shall be deemed to be applicable for works at all levels and positions.
- 10. Contractors should note that their rates should be inclusive of all attendance on their sub-contractors and also for making good any holes and chases left by the sub-contractors before the builder's work is completed.
- 11. The contractor shall be responsible for procuring all required materials sufficiently in advance and see that the work is never hindered for want of materials or due to any other reason or restrictions.
- 12. The contractor shall have to carry out all connected work within the boundary of the proposed work and inside the building if ordered to do so by the Architect/Employer at the rates quoted in the Schedule of items.
- 13. All materials which shall be used in the work must be from the list of the approved materials as mentioned in the specifications. Samples of materials proposed to be used shall be submitted for approval.
- 14. The rates for service connection charges include the cost of metering connection of PVC cables, cable sockets etc.
- 15. Distribution wiring shall include circuit wiring. No extra payment shall be made for circuit wiring.
- 16. Rates quoted for point wiring of PVC wires on surface shall include cost of switches, ceiling roses etc. on wooden board or partly concealed as stated in the Schedule of items. No extra cost for switches, ceiling roses, boards etc. shall be allowed.
- 17. Rates quoted for point wiring in surface conduit/concealed conduit will include switches, ceiling roses etc. on M.S. Board as specified. No extra cost for switches, ceiling roses, boards etc. shall be allowed.
- 18. The rates for erection of ceiling fan and fluorescent fittings must include the cost of supplying down rod as necessary and flexible wires, connection charges, fixing of regulator and testing etc.
- 19. The rates for plug socket point wiring shall include the cost of socket-outlet, plug top and control switch in box and necessary connection charges including earthing as specified.
- 19. The rates or fittings shall include cost of supply and fixing of fittings, lamps, etc. and connection and testing charge.
- 21. The rates for cable-laying shall include the cost of cable trenches with tiles, sands etc. and also the cost of saddle clamp (in case of surface wiring) providing G.I. pipes under road crossing, drain etc. necessary clamps etc.


