1. A copy of business registration certificate/certificate of incorporation.
2. A copy of PIN certificate.
3. A copy of valid tax compliance certificate.
4. Registration with the National Construction Authority (NCA) in the category of building, construction, and renovation works.
5. Bid bond of 2% of the bid sum from a reputable financing institution or an insurance firm.
6. Form of tender correctly filled, signed, and witnessed as required.
7. Confidential business questionnaire duly filled and signed.

8. NOTE:

- i. For People Living with Disability (PWDs), MUST attach registration documents with the Special Group.
- ii. For Special Groups (Youths, Women, People Living with Disability and Island Contractors) category, the contractor MUST attach certificate of registration from Registrar of companies or AGPO certificate.
- iii. Canvassing is highly discouraged and may lead to automatic disqualification.
- iv. Failure to comply with any of these requirements may lead to disqualification of the tender.

Prices quoted should be net, inclusive of all taxes and delivery costs expressed in Kenya shillings and shall remain valid for a period (120) days from the closing date of the tender.
